# 2.0 COURSE DESCRIPTION

This course is for students who are competent in reading and writing Modern Standard Chinese. Representative films produced in the major historical periods in Taiwan and Hong Kong are examined. The emphases are on the analysis of screenplays/films, as well as political, social, and cultural changes that are reflected in the films. Course readings include selected screenplays and film reviews published in Chinese journals as well as articles/chapters that provide historical background.

# 3.0 COURSE LEARNING OBJECTIVES

The course aims to enable students to:

- Critically analyze selected screenplays and reviews;
- Better understand the political, social, and cultural contexts of cinema in Taiwan and Hong Kong;
- Comprehend Hong Kong and Taiwan cinema and their impact on the two societies;
- Improve their abilities to engage in perceptive reading and critical thinking;
- Enhance their written and oral presentation skills.

# 4.0 DESCRIPTION OF CLASS METHODS

The learning activities include film screening as well as analysis and discussion of the film(s). Regular participation and active contribution to class discussion are essential and expected.

# 5.0 REQUIRED READINGS & TEXTS

Course readings, unless otherwise indicated, are to be found in course website. Suggested background reading: Christopher Berry and Mary Ann Farquhar, *China on Screen: Cinema and Nation* (New York: Columbia University Press, 2006).

# 6.0 METHOD OF EVALUATION/ASSESSMENT

- Participation 20% Regular participation and contribution to class discussion are essential and expected. Participation marks depend on the sufficiency of your preparation and the quality of your contribution, as determined by the instructor.
- Film review 15%

Assignment instructions will be distributed in class separately. It is due on August 1, 2023 (Tuesday). Submit your review to OWL - Assignment.

- Written test 15% A critical analysis of the film clips shown in the course. August 3, 2023 (Thursday).
- Group project 20%

4-6 students per group. Sign up for one each of the films listed under Screening. Conduct research, explore various themes, genres, discuss the cultural, historical, or social implications of the chosen topic and present findings in an engaging and informative manner.

• Final paper 30%

Analyze one screenplay or film covered by the course. You may choose a screenplay or a film that is not studied in the course with approval from the instructor. The film chosen should not be the same film of your review. The length of the paper should be around 3,000 words in Chinese. Papers are due without exception on **August 10, 2023 (Thursday)**. Submit your review to OWL - Assignment.

# 6.1 SPECIAL INSTRUCTIONS

- There is a penalty for late submission: one mark for each calendar day (Saturday and Sunday included) to a total of seven days. Assignments more than seven days late will not be accepted. No Extension will be given, except in the case of documented medical or compassionate circumstances.
- No make-ups will be given on the test, except in the case of documented medical or compassionate circumstances.
- Plagiarism detection software may be used in this course. Students may be required to submit their work in electronic form.

## **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. ## Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### Policy on Academic Consideration for a Medical/Non-Medical Absence

# (a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic

advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

## b) <u>Medical Grounds</u> for assignments <u>worth 10% or more of final grade</u>: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <u>https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</u>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

## <u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
