Course Description:

This course introduces students to the literary theory of ecocriticism and explores the representation of nature and environment in Chinese literature and film in contemporary era of industrialization, modernization, and urbanization. The course focuses particularly on the relationship that various Chinese communities have with the natural world and the influence of politics, ethnicity, gender, class on such relationship. The course is taught in Chinese.

Learning Objectives:

By the end of this course, students will be able to

- Outline the major developments in ecocriticism in Chinese literary and cultural studies;
- Identify some important writers, film directors, and their works that explore the environmental issues and raise public awareness about eco problems in China;
- Understand social, political, economic factors that influence environment through the lens of literary and visual representation;
- Develop analytical skills and critical thinking abilities in studying Chinese literature and film from the perspective of ecocriticism.

Attendance and Participation

Attendance and participation do not simply mean that you attend all classes, coming to class on time and staying until the end. It is most important that you read the texts and come to class prepared. You must actively participate in the discussion and interact with the instructor and your fellow students.

One component of participation includes your posting on the forum at OWL (5%). The forum posting involves finding texts, then posting what you have found/made and writing and posting a short commentary about it in relation to the course content. The "text" can be an essay, a book chapter, an excerpt from any form of a literary work (fiction, poem, etc.,), or a short video clip. It could be either the readings from this course or external sources you find by yourself. Once you have selected and posted your text, I then want you to add a paragraph or two of your reflections on it and on its relevance to the issue/subject assigned.

Test

The mid-term test will take place in class on **May 24**. It is two hours and a half in length and covers lectures and readings from the past sessions. Exam format will be given in class prior to the exam. No aids are allowed.

In-class quizzes

In this section, you will be given questions based on the class materials and lectures. You will compose an essay (one page per essay) by following academic rubrics to incorporate both your analysis and class materials to address the questions. No aids are allowed. No make-up for the missed quizzes, except in the case of documented medical circumstances.

Term Paper and Proposal

Students will write a research paper of at least 3000 words. Please provide a word count at the end of your paper. You must consult scholarly books and articles and not limit your research to Internet sources. All the primary and secondary sources must be appropriately cited in the paper and listed in your bibliography in given format. No form of plagiarism or academic dishonesty will be tolerated. The paper should be typewritten and double-spaced with a clearly defined thesis statement supported by relevant evidence. The electronic copy of the essay must be uploaded to OWL by the end of June 2. Specific instructions for the term paper and proposal will be provided in class.

Special Instructions:

There is a penalty for late submission of the term paper. Penalty is 1% for each calendar day to a total of three days.

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. Statement on Use of Electronic Devices

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clicker records are used to compute a portion of the course grade:

Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation.

The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University</u> (uwo.ca) requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

c) Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
