# **Course Description**:

This course will explore the political, economic, and social landscape of modern China through an examination of its systemic change in responses to capitalist modernization at the global level. It will introduce students to debates within the contemporary China studies on the image of China in the trend of globalization with the emphasis on China's engaging with transnational social, economic, and cultural dynamics, such as capitalism, democratization, urbanization, shaping of national identity, etc. The course will be taught in **English**.

1. Gain an overview of the economic, social and political development in China's modern history.

2. Acquire a general understanding of contemporary Chinese studies.

- 3. Deepen the understanding of the relationship between China and the world.

#### **Reflection Paper:**

## Attendance and Participation

Attendance and participation do not simply mean that you attend all classes, coming to class on time and staying until the end. It is most important that you read the texts and come to class prepared. You must actively participate in the discussion and interact with the instructor and your fellow students.

One component of participation includes yours posting on the forum at OWL. The forum posting involve finding texts, then posting what you have found/made and writing and posting a short commentary about it in relation to the course content. The "text" can be an essay, a book chapter, an excerpt from any form of a literary work (fiction, poem, etc.), or a short video clip. It could be either the readings from this course or external sources you find by yourself. Once you have selected and posted your text, I then want you to add a paragraph or two of your reflections on it and on its relevance to the issue/subject assigned.)

## Presentation and Report

Students will sign up for the session that they plan to do their presentation. The presentation topics will be available on a first-come, first-served basis. You should prepare a short oral presentation for 10 minutes and one or two questions for discussion. You are required to submit a report of your presentation and discussion questions one week after your presentation. Instructions on presentation and topics will be given during the class.

## Reflection Paper

This reflection paper is a self-reflective paper to express the effect of this course in supplementing (or changing) your ideas about China's political and economic structure. Your paper should be **no longer than one page (single space)** and contains:

- 1. the topic that you want to address;
- 2. the conventional understanding you have of this topic before taking the course.
- 3. explain how this course has refreshed your understanding of this topic.

## Weekly quizzes:

There will be 5 weekly quizzes in this course, each worth 2%. The quizzes will be posted in the subpage of the relevant unit in "Tests." Each quiz must be finished before the designated deadline.

## <u>Tests</u>

The mid-term test will take place in class on **July 27.** It is two hours in length and covers lectures and readings in the past sessions. You will choose two consecutive hours from the 24-hour window on that day to finish the exam. The final exam will be scheduled during the exam period. It will cover lectures and readings after the mid-term test. Exam format will be given in class prior to the exam.

#### Film Screening

There will two rounds of in-class film screening, on July 29 and Aug 12, respectively. You should consider the films as required texts and deal with these two films in the same way as you do with all class reading materials.

# **Special Instructions:**

1. Once you sign up your presentation, you cannot change your topic without the permission of the instructor. There will be no grade given in the case of no-show without prior notice.

2. There will be no make-up for the missed presentation, quizzes, and exams. Failure to complete your presentation, quizzes and the two exams will result in a grade of zero without proper documentation. A student who misses the presentation, quizzes or tests must provide documentation to the counseling office (not the professor). If this documentation is accepted as a valid reason for missing a presentation, quizzes, or tests, then (and only then) the weight of the missed presentation will be reallocated to the report, the weight of the missed quiz will be relocated to other quizzes, and that of missed test will be reallocated to the final exam. This is the only method of accommodation for missed sessions.

If clicker records are used to compute a portion of the course grade:

### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). #### Policy on Academic Consideration for a Medical/ Non-Medical Absence

# (a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

## (b) Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
