# **Course Description:**

This course examines various aspects of modern Chinese society through the lens of fiction. It gives students an overview of representative works of Chinese fiction (short stories, novellas, and novels) from the Republican to contemporary periods. These works provide a kaleidoscopic insight into history, society, politics, and culture in modern and contemporary China. Students will explore artistic features as well as socio-historical contexts and implications of the narratives. Film adaptations of selected works will be introduced to enhance students' understanding of literary texts. The course is taught in English.

**Antirequisite(s):** The former Centre for Global Studies 2311F/G

## **Learning Objectives:**

By the end of this course, students will be able to

- Understand the developments of Chinese fiction in modern and contemporary periods;
- Identify major narrative forms in modern Chinese fiction and their distinctive features;
- Develop analytical skills and critical thinking on modern Chinese fiction;
- Examine historical changes as well as political, social, economic, and cultural characteristics of modern Chinese society.

#### **Class Methods**:

This is a blended course with both synchronous and asynchronous components. Tuesday sessions are asynchronous; students watch online materials and participate in forum discussions at a time of their choosing. Thursday sessions are synchronous lectures, which means that students meet as a group via Zoom. The recordings will be available for one week from the date of lecture.

# Participation and Discussion

You are expected to attend the lectures if possible. It is most important that you read the texts and come to class prepared. You must actively participate in the discussion and interact with the instructor and your fellow students. If you are unable to attend the lectures, you need to post your reflections on the Discussion Forum by Thursday, which will be evaluated as your participation.

# Proposal and Term Paper

You are required to submit a proposal for your term paper on **March 18**. Once you submit your proposal, you cannot change your topic without the permission of the instructor. Students will write a research paper of 2000-2500 words (double-spaced, 1-inch margins, 12-pt Times New Roman) based on the proposal. Please provide a word count at the end of your paper (Bibliography is an essential part of your paper, but is not included in the word count). All the primary and secondary sources must be appropriately cited in the paper and listed in your bibliography in MLA format. The electronic copy of the essay must be uploaded to OWL on **April. 8**. Students must complete an academic integrity checklist before submitting the paper. No form of plagiarism or academic dishonesty will be tolerated. Specific instructions for proposal and term paper will be provided in class.

#### **Tests**

The mid-term test will take place on **March 4**. It is two hours in length and covers lectures and readings in the first six weeks. The final exam is scheduled during the exam period. It is two hours and will be based on all lectures and readings covered after the mid-term test. Both tests are open-book exams.

# Late Penalty

There is a penalty for late submission of proposal and term paper. The penalty is 5% for each calendar day to a total of seven days. Assignments more than seven days late will not be accepted. No extension will be given, except in the case of documented medical or compassionate circumstances.

# **Notice of Recording:**

All of the remote learning sessions for this course will be recorded. The data captured during these recordings may include your image, voice recordings, chat logs and personal identifiers (name displayed on the screen). The recordings will be used for educational purposes related to this course, including evaluations. ## **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (https://www.turnitin.com/).

## **Computer-Marked Tests/Exams**

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

# **Clickers**

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/Academic\_Consideration\_for\_absences.pdf are met.

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the

academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

# Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed **a maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will
  require students to present a <u>Student Medical Certificate (SMC)</u>, signed by a licensed medical or
  mental health practitioner, detailing the duration and severity of illness, or appropriate
  documentation supporting extenuating circumstances to the Academic Counselling unit in their
  Faculty of registration no later than two business days after the date specified for resuming
  responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

# Policy on "Academic" Accommodation - Medical / Non-Medical Grounds

(a) <u>Medical Grounds</u> for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email <u>huronsss@uwo.ca</u>.

University Senate policy, which can be found at,

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_medical.pdf , requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# (b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

## (c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed <u>Accommodation Request Form</u>. Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
