## Chinese 3340A: Business Chinese 1 Intersession 2021

#### **COURSE DESCRIPTION**

本课是一门高年级商务汉语课。课程在内容上使用商务题材的载体与现实的 "商务"世界相联系,帮助学生提高运用汉语去解决实际问题的能力,包括通过汉语获取 信息的能力和使用汉语完成特定任务的能力,在提供系统语言训练的同时着意加强对学生 语言学习能力的培养。

**Calendar Description.** This course is intended for students who can read and write Modern Standard Chinese. Students will develop specific knowledge and skills in business communication in Chinese. Business etiquette and protocol will be discussed. Translation and competence in interpretation will be fostered by the study of business terms, documents, and practices.

#### **COURSE LEARNING OBJECTIVES**

This course aims at helping students to develop both linguistic skills and cultural knowledge in business Chinese. It focuses on developing these competencies as required in successful business relationships. Upon completion of this course, a student will:

- 1) Acquire an enriched Chinese business vocabulary;
- 2) Gain familiarity with different styles of language in various business activities;
- 3) Expand their skills to carry on discussions of business issues in standard Chinese;
- 4) Develop confidence in effective use of standard Chinese in the sphere of business;
- 5) Acquire knowledge of the methods and styles of business communication and translation.

## DESCRIPTION OF CLASS METHODS

The course is scheduled Monday through Thursday, 9:30am-12:30pm. Our classes will be conducted in a mixed online format. For each session, we will meet on Zoom via our course OWL for at least one hour. You will work with the course textbook, lesson by lesson, as indicated in the course schedule below.

With the understanding that language is learned rather than taught, I will present the lessons and guide you through your studies of the course materials. Assessment of your achievement is centred on practical application rather than on linguistic forms. Some of the

language tasks related to the course or to your language learning skill development will require Zoom discussions with me and/or your classmates while others will be completed offline individually or in groups. You will also study samples of oral applications in business-relevant interpersonal communication.

This is an intensive, advanced-level language course. It is essential to have written discussions as well as exercises with simulated real-world tasks connecting the classroom to China's current business environment. You will learn to absorb texts which provide essential information about common business topics in relatively formal language. You are expected to undertake sample language tasks to learn new aspects of language use in business contexts.

## 4. Group Project 10% (1 x 10%)

Each group will prepare a brief written outline in ppt format (about 10 slides)

with voice-thread for a ten-minute report about a subject selected by the instructor from one of the lessons.

Written work must be submitted on OWL by 12:30pm on its due date. A late penalty will apply, as indicated for each component.

#### **Statement on Use of Electronic Devices**

#### **Statement on Use of Personal Response Systems ("Clickers")**

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

## **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. #### Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# (b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email <a href="mailto:huronsss@uwo.ca">huronsss@uwo.ca</a>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed <a href="Consideration Request Form">Consideration Request Form</a>. Late penalties may apply at the discretion of the instructor.
