### **Course Methods**

This is a synchronous online course. We will have virtual Zoom classes every Monday and Wednesday between 1:30-4:30pm, where your participation is valued and will be essential to your success in the course.

If you are unable to participate in synchronous Zoom classes, please contact the instructor at the start of term to make other arrangements if you have appropriate grounds for accommodations.

Please note that this is an accelerated 6-week summer course. It is your responsibility to keep pace with the course requirements, but if you begin to fall behind, please contact the instructor immediately.

# **General Course Description**

Storytelling defines who we are and our relation to the community, the nation, and the world. This course explores the rich and diverse traditions of storytelling: such as, oral tales, short stories, classic fiction, and graphic novels. Instruction by lecture and tutorials; emphasis on developing strong analytical and writing skills.

This class of 1027F will strive to create a setting in which everyone feels that their dignity, identity, privacy, personal space, and autonomy are respected. Sensitive topics such as oppression, discrimination, and violence will come up in this class. We will not skirt difficult issues. This course contract details some of these topics. Talk to your instructor if you have any concerns about course material or about respectful language. Please keep in mind that pejorative language will not be tolerated. I encourage all my students to speak to me if they ever feel uncomfortable in the classroom and to challenge my own use of language when they find it problematic.

# **Learning Outcomes**

- improve your critical reading and writing in ways that will enable success in a wide variety of University courses
- explore a wide range of forms of creative expression and further your appreciation of diverse cultural productions and practices
- develop an interdisciplinary perspective on a variety of narrative media: for example, the poem, the novel, and the film
- become capable of identifying, analyzing, and interpreting basic narrative elements, such as plot, character, point of view, theme, setting, imagery, diction, tone, figures of speech, and tropes
- write logically and persuasively in fluent, standard English using the appropriate conventions for scholarly-critical writing
- design strong thesis statements and structured arguments in persuasive original essays and projects using MLA format and secondary research material integration (i.e. using quotations and paraphrases)
- evaluate the relevance, reliability, and usefulness of research sources, including those obtained through the Internet
- survey major literary and cultural movements and their socio-political context
- engage in an experiential and collaborative project that highlights the real-world applications of studying narrative

# **Brief Description of Assessments**

# **Participation**

This is not an attendance grade. In order to receive a high participation grade, you must actively participate in synchronous classes, activities, and discussions. This requires that you come to virtual classes prepared (i.e. having read/watched the texts) and engaged (i.e. participating in breakout rooms, completing in-class activities, etc.).

### **Entrance Interviews**

I will conduct 5-10 minute individual meetings with each student in the course, to be scheduled on our first day of class (Monday May 16<sup>th</sup>). These will count towards your participation grade. You will select a time-slot for your interview under "Sign-Up" on the OWL Toolbar.

# Essay One

A formal MLA-style 500-word essay written on a single primary text. This is not a research assignment. Your essay should focus on close reading and textual analysis.

\*For this assignment, you have the option of alternatively submitting a creative piece (poetry, short story, or oral storytelling/performance).

# Essay Two

A formal MLA-style 500-word essay written on a single primary text. This is not a research assignment. Your essay should focus on close reading and textual analysis.

# Peer Review Report

Students will bring a full draft of their research essay (minimum 1000-words) to a peer review session, where they will swap their rough draft with another student and give constructive feedback according to an outline. You will be evaluated on the quality of your draft and your

feedback to your peer. If you do not submit your own rough draft for review, you will receive an automatic zero.

# Research Essay

A formal MLA-style 1250-word essay written on a single primary text and with the use of at least one peer-reviewed secondary source.

# Final Exam

A 24-hour take-home final exam that will consist of three sections: short answer questions, passage analysis, and a comparative essay.

### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. ### **Statement on Use of Personal Response Systems ("Clickers")**

Personal Response Systems ("clickers") may be used in some classes. # **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. ### Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

(b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email huronsss@uwo.ca.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed Consideration Request Form. Late penalties may apply at the discretion of the instructor.
