# Land Acknowledgement

Situated in the region of southwestern Ontario and the London area, Huron University (and the institution of Western) is located on the traditional lands of the Anishinaabek (also Nishnaabeg), Attawandaron (also known as the Neutral), Haudenosaunee, and Lūnaapéewak peoples, on lands connected with the London Township and Sombra Treaties of 1796 and the Dish with One Spoon Covenant Wampum. This land continues to be home to enormously diverse Indigenous Peoples (First Nations, Métis, and Inuit) whom we recognize as contemporary stewards of the land and vital contributors to our local and global societies. This class of 1042E will strive to create a setting—whether in person or virtually—in which everyone feels that their dignity, identity, privacy, personal space, and autonomy are respected. Sensitive topics such as oppression, discrimination, and violence will come up in this class. We will not skirt difficult issues. This course contract details some of these topics. Talk to us (your instructors) if you have any concerns about course material.

# Course Description

This introductory course explores (and practices!) a diverse range of storytelling methods, concepts, and forms of creative expression. As a class, we will approach the study of culture and literature through a variety of different creative mediums and cultural "texts" including, but not limited to, documentaries, essays, film, graphic fiction (e.g. comics), nonfiction and oral narrative, two novels, some podcasts, some poetry, a play, some short stories, visual art, and some YouTube clips. We will trace diverse *intersectional* and *entangled* perspectives related to different literary historical periods, genres, cultural narratives, and critical approaches—also paying close attention to our own ever-changing historical moment.

This course equips students with analytical, conceptual, research, and writings skills with the overall goal of becoming better critical and creative thinkers.

# **Learning Outcomes**

- improve your critical reading and writing in ways that will enable success in a wide variety of University courses
- \* explore a wide range of forms of creative expression and further your appreciation of diverse cultural productions and practices
- develop an interdisciplinary perspective on a variety of narrative media: for example, the poem, the novel, and the film
- become capable of identifying, analyzing, and interpreting basic narrative elements, such as plot, character, point of view, theme, setting, imagery, diction, tone, figures of speech, and tropes
- write logically and persuasively in fluent, standard English using the appropriate conventions for scholarly-critical writing
- design strong thesis statements and structured arguments in persuasive (original) essays and (team) projects using MLA format and secondary research material integration (i.e. using quotations and paraphrases)
- evaluate the relevance, reliability, and usefulness of research sources, including those obtained through the Internet
- survey major literary and cultural movements and their socio-political context
- \* articulate assessments of texts in class and participate in collaborative learning

#### Course Methods

This course is co-taught by two instructors who will employ distinct teaching methodologies in the Fall/Winter semesters respectively to appeal to the diverse and multifaceted range of student learning styles. Your instructors will clarify their course expectations in terms of synchronous vs. asynchronous course content <u>via the first video lecture of each term</u> (found on our 1042E OWL site under Course Content > Week 1: Introduction). All students (regardless of time zones) will be able to fully participate and meet class requirements.

# **Brief Description of Course Assessments**

Participation: 10% Our 1042E, 552 OWL site is our main classroom for the semester.

## Fall, 2020:

Your participation grade will be evaluated based on OWL Forum posts and quizzes.

### Winter, 2021:

You will be expected to complete all the required readings, viewings, and weekly material by the set deadline for each week, participate in online discussions and writing activities, and submit all your assignments for assessment in a timely manner. We will regularly gather over Zoom for scheduled class meetings that will include course discussion. Other scheduled class time (i.e. on Tuesdays) should be used for completing the course activities.

I will take attendance at Zoom meetings, and you should attend, unless you have time zone constraints (in such cases, please let me know). Alternatively, your participation will be graded based on you completing the online discussion activities set out each week under our <u>weekly</u> course content on OWL.

### **Essay: 15%**

A 1000-word formal essay on one text studied in the first semester written in MLA style. **Due** Oct. 15<sup>th</sup>

# **Group Multimedia Project: 15%**

In groups of 3-4, students will create a series of short podcasts or videos that investigate or research a key topic or theme and apply it to course text(s). There will be both a group grade and an individual grade based on your group members assessment of your performance as a team member. **Due Nov. 10**<sup>th</sup>

#### Midterm: 10%

An online exam that consists of multiple choice, true/false, and short answer questions to evaluate student's comprehension of course material. **Dec. 1**<sup>st</sup>

# **Annotated Bibliography: 5%**

This assignment tests your <u>Research Session Skills</u>; it requires three short annotations of research sources you might plan to use for your final research project: **Due Jan. 28**<sup>th</sup>

# Formal Written Research Proposal for Final Essay Research Project: 10%

This is your opportunity to pitch your project and refine your thesis before proceeding with indepth research and the crafting of your final essay/project structure. **Due Mar. 4**<sup>th</sup>

#### Course Interviews: 2 x 5%

Course discussion with your instructor. The first interview (Week 1) will be approximately five minutes and it will consist of a course questionnaire. This is a pass/fail assignment. The second interview (Week 10) will also be a brief conversation. During this interview, your instructor will ask you to articulate your assessments of some of the second semester course material. Sign-up sheets will be distributed in early January and early March respectively.

#### Final Essay Research Project: 25%

This is your opportunity to display what you have learned in a formal, extended discussion of <u>at</u> <u>least</u> two texts studied throughout the year. It will build on what you have learned throughout the course and should be developed from your projects, your annotated bibliography, and your proposal. It will employ secondary sources; it will be well written and presented in a clear and compelling manner; and it will be properly documented using MLA style. **Due TBD April.**

#### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). The Student Medical Certificate is available online at <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</a>.

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

#### Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a maximum of two self-reported absences between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a <a href="Student Medical Certificate">Student Medical Certificate</a> (SMC), signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors no later than 24 hours after the end of the period covered by the Self-Reported Absence form, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

# Policy on "Academic" Accommodation - Medical / Non-Medical Grounds

# (a) <u>Medical Grounds</u> for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email <u>huronsss@uwo.ca</u>.

University Senate policy, which can be found at, <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_medical.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_medical.pdf</a>, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</a>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# (b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# (c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed <u>Accommodation Request Form</u>. Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
