2. Course Description

This is a first-year essay course in French, providing an introduction to French Studies, with an emphasis on language, culture, and various forms of expression and analysis. FRE 1900E aims to improve your ability to speak and write in French, but it's not your traditional French grammar class.

Each week, students will also explore a text from the Francophone world and discuss a business column published in the daily newspaper *Le Monde*. We will cover specific grammar or vocabulary skills found in the material.

During the Fall Term, we'll study a podcast based on the true story of the "French Connection" drug trafficking operation, allowing us to travel from Southern France to Cuba, from Montreal to New York City. During the winter Term, we'll study a podcast exploring the work of journalists covering the LuxLeaks/Panama Papers story.

Every Thursday (except on test days), there will be a dictée, based on an excerpt taken from a novel, a play or a poem. This will be assessed by students themselves.

A dedicated "wild card" space will be available for the students to bring to the table a French language topic of their choice.

Assignments will consist of, quizzes, tests, and a final paper where students will discuss the column or the story that they enjoyed the most during the year.

3. Course Learning Outcomes

FRE 1900E aims to improve your ability to speak and write in French while exploring French and Francophone literature and current affairs from a French-based perspective.

<u>Attendance and Active Participation:</u> Active participation and attendance is required for this course. 10%

<u>Grammar Tests:</u> There will be two one-hour, in-class tests per term. Tests will cover material covered in class and a review class will be held before each test. **4 tests = 40%**

<u>Quiz en classe « Podcast »</u>: There will be 3 « 1 hour quizzes » per term based on 2 series of podcasts. Each quiz will consist of a series of comprehension questions and short essay style questions on the assigned podcasts. **6 quizzes = 20%.**

• Fall Term podcasts: « French Connection: Marseille, Montréal, New York ». A podcast by France Culture and Radio-Canada. « Des années 1950 aux années 1970 s'est opéré un gigantesque trafic d'héroïne entre la France et les États-Unis ayant Montréal comme plaque tournante. L'alliance de diverses organisations criminelles et d'un nombre incroyable de trafiquants français, canadiens et américains avait alors permis de mettre en place le plus important trafic de drogue jamais réalisé pour l'époque, un réseau mythique aujourd'hui connu sous le nom de la French Connection. Stéphane Berthomet retrace dans ce balado l'histoire de ce réseau et met en lumière les rôles méconnus qu'y ont joués Montréal et certains Québécois. »

A podcast by France Culture. « Pendant cinq ans, Édouard Perrin a enquêté, seul d'abord, puis au sein du Consortium international des journalistes d'investigation et a mis à jour des montages financiers aux multiples ramifications. Son enquête l'a conduit au Luxembourg, le cœur de l'Europe, puis au Panama, paradis off-shore sous les tropiques. Lancées à partir de fuites de documents ultra secrets, ces enquêtes ont valu deux procès au journaliste. Mais elles ont aussi permis aux services fiscaux français de récupérer beaucoup, beaucoup d'argent. »

<u>Travail final à la maison/Final take home exam</u>: Length 1500 to 2000 words. Student will be able to select an economics article from *Le Monde* or a literary text studied in class for their essay. Alternatively, students may write their essay on one of the podcasts studied in class. Students will have to present a draft and discuss it individually during the last class of the Winter term in an oral presentation. The essay will feature some mandatory rules such as the use of certain tenses. **Due date to take home exam to be determined according to the official exam schedule.**30% (5% for the oral presentation and the rough draft, 25% for the final paper).

Appendix to Course Outlines: Academic Policies & Regulations 2021 - 2022

Prerequisite and Antirequisite Information

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

Pandemic Contingency

In the event of a COVID-19 resurgence during the course that necessitates the course delivery moving away from face-to-face interaction, all remaining course content will be delivered entirely online, typically using a combination of synchronous instruction (i.e., at the times indicated in the timetable) and asynchronous material (e.g., posted on OWL for students to view at their convenience). Any remaining assessments will also be conducted online at the discretion of the course instructor. In the unlikely event that changes to the grading scheme are necessary, these changes will be clearly communicated as soon as possible.

Statement on Use of Electronic Devices

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_illness.pdf are met.

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). The Student Medical Certificate is available online at https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf.

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Policy on Academic Consideration for a Medical/ Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

(b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email huronsss@uwo.ca.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed Consideration Request Form. Late penalties may apply at the discretion of the instructor.
