### **Course Description:**

We live in a fast-changing world with interconnected crises, some are calling it a permacrisis1. The ability to understand, shape, anticipate, accept and adapt to change is a skill that every leader should constantly cultivate personally and collectively. Even more so in a society where the information overload constantly pulls our attention in a new direction favouring short-termism and immediate results over longer term benefits.

"A broad range of researchers, artists, technologists and philosophers are now converging on the idea that short-termism may be the greatest threat our species is facing this century." (NESTA, 2019)

Thinking about and shaping the future should be a whole-of-society endeavour to ensure the benefits are widespread and decisions have legitimacy by including as many perspectives as possible.

During this course, students will learn about the importance of honing their future-oriented thinking to improve decision-making and taking action. Students will practice different tools to develop their own future-thinking skills and to develop participatory futures. Including how to: identify signals of change, stay up to date with the main future forces, imagine vivid future scenarios, use backcasting methods and adopt a flexible mindset to avoid a resistance to change and to different perspectives.
