### **ANTIREQUISITES:**

Mathematics 2124A/B, 2155F/G, the former 2155A/B, Statistical Sciences 2035, 2141A/B, 2857A/B, the former 2657A

#### **COURSE OUTLINE:**

Topics covered include techniques of counting, probability, discrete and continuous random variables. Students are expected to demonstrate an understanding of these concepts and an ability to apply them in solving a variety of problems.

#### **COURSE WEB SITE:**

Various supplemental materials, such as homework problems, solutions to the homework exercises etc, are posted on the course OWL web site. In addition, there are forums on which students may post questions. Important information will be posted on the Announcement thread of OWL or will be communicated via OWL messages. All students are expected to be aware of information, and make use of materials, posted on the course web site, as well as making sure they complete the Online quizzes within the given time frame.

#### WHAT IS EXPECTED OF THE STUDENT?

Students should make a serious effort to understand all course material, and do all the assigned homework. The student must assume responsibility for staying up to date with course content and for being aware of posted deadlines. It is up to the student to seek out help when needed. The student is responsible for being aware of all relevant information posted on the OWL web site, especially information posted on the Announcement thread.

#### **EVALUATION OF STUDENT PERFORMANCE:**

Students will be assessed on the basis of Online Quizzes, two online, synchronous, proctored Term Tests, and an online, synchronous, proctored Final Exam.

The dates of the two Term tests are:

#### May 20 2021, 11.00am-12.30pm EDT and June 4 2021, 11.00am-12.30pm EDT.

Test 1 covers all of Chapter 1. Test 2 covers all of Chapter 2.

The Final Exam will be 3 hours in length, covering all of the course material. This exam will be scheduled by the Registrar's Office during the exam period, June 21-22 2021.

#### Calculation of Final Grade:

Each Term test will count for 20%, the Final Exam will count for 40% and the Quizzes will count for 10%. The remaining 10% weight will be assigned to whichever of the 3 tests/exams is the student's best mark.

#### Notes:

- 1. The tests and exam will have some multiple choice and some written response questions.
- 2. NO calculators or other electronic devices, no notes, formula sheets or any other aids are allowed on tests and exam.
- 3. There are no make-up dates for the Term tests. If a student is absent with justification (an advisor's accommodation form or an approved self-reported absence), then the weight of the term test will be shifted to the final exam. See Absence/missed work for further details.

#### **CLASS POLICIES:**

#### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. #### Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_illness.pdf are met.

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. #### Policy on Academic Consideration for a Medical/ Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the

presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# (b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email <a href="mailto:huronsss@uwo.ca">huronsss@uwo.ca</a>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
