## **Course Description**

A multidisciplinary approach to the study of human behaviour in organizations from the individual, group and organizational levels of explanation.

## **Course Learning Outcomes**

By the end this course, you should be able to:

a) understand, explain, and apply core concepts from the field of organizational behaviour

b) understand the relationships between leadership, ethics, and motivation c) identify and understand key sources of success, wellbeing, and weakness in organizations, as well strategies that can be used for preventing and/or responding to challenges

## 1. Leadership Experience Analysis – 30%

Our first assessment involves:

a) reading Golliher's Think Like a Horse...

- b) participating in an equine-facilitated leadership skill building session
- c) writing an in-class analysis of both

On Wednesday October 5<sup>th</sup>, we will depart as a class by bus from Huron at 8:45am to participate in an equine-facilitated leadership skill building session at a farm near London. We will return to campus ideally for 11:30am and not later than noon.

The written, in-class assessment will take place during class on Wednesday October 12<sup>th</sup>. Further details will be provided in class.

## 2. Test – OB and/in Severance – 30%

This assignment involves watching and applying course concepts to the acclaimed television show *Severance*. The assessment will take place in class on Wednesday November 16<sup>th</sup>. Further details will be provided in class.

## 3. Final Project – 25%

This summative assignment will task you with collaborating in a small group of five students to respond to an assigned workplace challenge, collectively presenting your action plan to the class, and submitting a written report individually. The grade will be calculated by combining a group mark of 10% for the presentation (that is, one mark out of 10/group) plus your individual score out of 15 for a written report submitted the day of your presentation. Presentations will take place in class on December 5<sup>th</sup> and 7<sup>th</sup>.

## 4. Participation – 15%

Our class will be interactive and participatory, and involve regular discussion, question asking and answering, and small and large group activities. Of course, you must be present to participate, but this not an attendance mark. Thoughtful active learning and quality verbal engagement throughout the semester are essential to your individual and collective success and will earn this grade.

 $\geq$ 12/15 (A – A+) = excellent to outstanding participation. Contributions consistently demonstrate strong preparation (completed any assigned readings), comprehension, collaboration, incisive thinking, and curiosity.

10.5-11.5/15 (B) = good to very good participation. Contributions often demonstrate preparation, comprehension, collaboration, insight, and curiosity.

9-10/15 (C) = fair participation. Contributions occasionally or unevenly demonstrate preparation, comprehension, collaboration, insight, and/or curiosity.

7.5-8.5/15 (D) = weak participation.

<7.5/15 (F) = does not meet the minimum standard.

I recognize that things happen on occasion which mean you must miss a class. If you miss a class, you do not need to inform me of why, but it is your responsibility to obtain notes from another student to get caught up on missed material. Lecture/class notes will not be provided but questions are welcome after you have obtained notes and read through the pertinent content. One missed class will not negatively affect your participation grade.

Having side conversations, texting, messaging, and/or using a computer for nonclassroom related purposes will negatively affect your participation grade. Doing any of these things undermines your ability to learn and is disrespectful to everyone around you and to me. Participation includes attentively listening throughout our classes.

All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (http://www.turnitin.com).

#### Statement on Use of Electronic Devices

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

#### Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### Academic Consideration for Missed Work

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

#### Policy on Academic Consideration for a Medical/ Non-Medical Absence

#### (a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

#### b) <u>Medical Grounds</u> for assignments <u>worth 10% or more of final grade</u>: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# <u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
