PREREQUISITES:

Ontario Secondary School MCV4U or equivalent (High School Calculus), or Mathematics 0110A/B.

ANTIREQUISITES:

Applied Mathematics 1201A/B, 1413, Calculus 1301A/B, 1501A/B, Mathematics 1230A/B. **If Calc 1000A/B or 1500A/B was completed after Sept. 1 2016 it is an antirequisite** (but not if it was completed before that time).

COURSE OUTLINE:

Logarithmic, exponential and trigonometric functions; integration, area; techniques of integration, improper integrals; functions of several variables, Second Partials Test, Lagrange Multipliers; differential equations, applications of differential equations.

COURSE WEB SITE:

Various supplemental materials, such as required extra homework problems, solutions to the homework exercises etc., are posted on the course OWL web site. In addition, there are forums on which students may post questions. Important information will be posted on the Announcement thread of OWL or will be communicated via OWL messages. All students are expected to be aware of information, and make use of materials, posted on the course web site, as well as making sure they complete the Online quizzes within the given time frame.

WHAT IS EXPECTED OF THE STUDENT?

Students should make a serious effort to attend all classes, understand all course material, and do all the assigned homework. The student must assume responsibility for staying up to date with course content and for being aware of posted deadlines. It is up to the student to seek out help when needed. The student is responsible for being aware of all relevant information posted on the OWL web site, especially information posted on the Announcement thread.

EVALUATION OF STUDENT PERFORMANCE:

Students will be assessed on the basis of Online Quizzes, 2 Term Tests, and a Final Exam.

The Online Quizzes are completed in OWL. See the Quiz Schedule and Quiz Information documents posted on the "Start here please :)" page on the site.

The 2 Term Tests, each 90 minutes in length, will be held on:

Friday February 10, 2022 and Friday March 17, 2022

The first test covers up to and including section 5.4 (no area).

The second test covers Area, supplement 2, Ch. 6, supplement 3, 7.1, and 7.2.

The Final Exam will be 3 hours long, covering all of the course material. This exam will be scheduled by the Registrar's Office during the April Exam Period.

Calculation of Final Grade:

Each Term Test will count for 20%, the Final Exam will count for 40% and the Class Work component will count for 10%. The remaining 10% weight will be assigned to whichever of the 3 tests/exams is the student's best mark.

Notes:

1. The Tests and Examination will all have some multiple choice questions and some written answer questions.

2. NO notes, formulas sheets, calculators or other electronic devices or any other aids are allowed on tests and exams.

ABSENCE / MISSED WORK:

Statement on Use of Electronic Devices

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

Policy on Academic Consideration for a Medical/ Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on medical grounds for assignments worth less than 10% of the final

course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

b) <u>Medical Grounds</u> for assignments <u>worth 10% or more of final grade</u>: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <u>https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf</u>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

<u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
