Since the Early Modern period, philosophers have sought to spell out the relationship between epistemic theory and scientific practice. More recently, these efforts have given rise to a number of naturalistic epistemologies, i.e., endeavors to study knowledge using the methods of science. This course will examine a number of these epistemologies, and in doing so confront the following questions: Which sciences should inform epistemic theory? What role should a priori intuition play in epistemic theorizing? What epistemological insights can we gather from the psychology of human judgement?

### **COURSE LEARNING OBJECTIVES**

On successful completion of this course, students will be able to:

1. Explain the principal differences between traditional and naturalized epistemology.
2. Formulate and defend a view about the relevance of scientific methods to epistemic theory.

### **CLASS METHODS**

This course consists in weekly lectures that I will post on Voice Thread (see tab on OWL) and a weekly tutorial meeting via Zoom. Each week's lecture is meant to be watched before the tutorial. You will also be expected to have done the relevant readings before we meet, so that we can discuss all the course material. We will discuss the strengths, weaknesses, and implications of the philosophical positions under consideration that week. I will invite questions, and pose questions to you. In other words, this is our weekly opportunity to play with the ideas in this course.

I ask that you arrive at the meeting on time. No one will be admitted to tutorials after 11:35am. I also ask, but do not require, that you turn your camera on, since it's easier have an interesting, responsive conversation when every participant's face can be seen. These conversations also benefit from a lack of distractions, so please limit your access to possible sources of distraction during tutorial meetings, eg: phone; television; roommates; Facebook; etc.

## **METHODS OF EVALUATION**

10% Class participation

Your class participation grade is determined by your performance in tutorial meetings. An excellent grade requires you to attend every meeting, actively contribute to the conversations, and give the discussion your undivided attention.

20% Lecture questions (due before tutorial each week)

Every week's lecture includes a lecture question that must be answered for credit. Your answers must be submitted to appropriate Forum thread on OWL before the following tutorial (on Wednesdays). Your answers will be graded (out of 5) based on their clarity, accuracy, and relevance to the question. If you write an insightful, relevant response to another person's answer by the end of the week, you will receive 1 bonus mark.

30% Assignments (15% each, due by January 25<sup>th</sup> and March 1<sup>st</sup>)

Each of these two assignments requires you to respond to a podcast episode that discusses an important aspect of the course material. The grading rubric is included in the assignment.

5% Essay outline (due by March 29<sup>th</sup>)

You are responsible for choosing your own topic for the final essay. Your topic can relate to any of the course material. Your essay outline must include: a research question, a search report, and an annotated bibliography. The grading rubric is included in the assignment.

35% Essay (due by April 12<sup>th</sup>)

Your essay of approximately 3,000 words will be on a topic of your choosing, and my approval. The grading rubric is included in the assignment.

LATE PENALTY: the penalty for submitting assignments late is 3% per day, including weekends.

ACCOMMODATIONS: All requests for accommodations must go through Academic Counselling and be approved by me. If your request for accommodation includes an extended deadline, you must request an extension *before* the original due date. If your request is successful, I will set a new deadline for submission.

Missed tutorials cannot be accommodated for any reason, since there is no comparable alternative to participating in class.

#### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<https://www.turnitin.com/>).

### **Computer-Marked Tests/Exams**

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

### **Clickers**

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence

### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

### **Requests for Academic Consideration Using the Self-Reported Absence Form**

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a **maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a **Student Medical Certificate (SMC)**, signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities.

- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

### **Policy on “Academic” Accommodation - Medical / Non-Medical Grounds**

- (a) **Medical Grounds for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email [huronsss@uwo.ca](mailto:huronsss@uwo.ca) .**

University Senate policy, which can be found at,

[https://www.uwo.ca/univsec/pdf/academic\\_policies/appeals/accommodation\\_medical.pdf](https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_medical.pdf) , requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the “home faculty” is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor’s decision is appealable to the Dean.

- (b) **Accommodation on Medical Grounds for assignments worth less than 10% of final grade: Consult Instructor Directly**

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may **not** collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

**(c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising**

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed [Accommodation Request Form](#). Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
