### **Delivery**

This course will be taught online, making use of the interactive Zoom platform. Classes will run live on the days and at the times indicated, which were the days and times originally specified in the Western timetable. For those who for one reason or another have no access to the live sessions, each day's Zoom audiovisual files will be posted on the OWL site for this course so that they will be available for students to view and listen to at their own convenience.

### Description

The objective of this course is to familiarize students with a number of different problem areas associated with the growth of economic globalization since the mid-20th century. Topics will include: the nature of obligation; the idea of international justice; the applicability of utilitarianism; the tension between liberal universalism and national sovereignty; human rights; resource distribution; international trade; health and healthcare; and international migration.

### **Objectives**

Students will learn to assess the comparative seriousness of the philosophical problems that arise in connection with these phenomena. In addition, they will develop the skills to make comparative assessments of various solutions to these problems offered by philosophers working mainly in the last 40 years or so, and by doing so, gain a basic knowledge of many of the central themes that appear in the interplay between thinking about economic phenomena associated with globalization on the one hand, and problems about social justice, on the other.

### **Course Method**

Lecture; with professor/student and student/professor question/answer exchanges.

#### Assessment:

Students' grades will be determined based in part on **two short essays** – 4-5 double-spaced pages in length, and **each worth 33** % – for a total of **66** %.

There will also be a 24-hour open book final examination worth 34 %.

- 1. The due dates for the essays are Monday, June 7 and Monday, June 14
- 2. The essays **MUST** be submitted electronically on **OWL** by 3:30 PM on the relevant due dates. Since this is an online course, obviously no hard copies are required. For each essay, the topic will appear on **OWL** on the Friday preceding the due date. The topic will not be handed out in class. **Late essays will not be graded, except on the recommendation of the Academic**

Counselor. Extensions will not be granted for any reason, except upon the recommendation of the Academic Counselor.

3. The **final exam questions** will be posted on the OWL site for this course. The final exam date will be scheduled by the Office of the Registrar during the June examination period. Students will have to write two short essay answers  $-1\frac{1}{2}$ -2 single-spaced pages each. Students will have to upload their exams on OWL by the specified date and time. In normal circumstances, I would set a two-hour time limit for exactly the kind of exam that will be given in this course. In order to make allowances for the extraordinary difficulties caused by Covid-19, students will be given 24 hours to complete the exam.

If clicker records are used to compute a portion of the course grade:

### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. ### Policy on Academic Consideration for a Medical/ Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

(b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email <a href="https://huronsseguwo.ca">huronsss@uwo.ca</a>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed Consideration Request Form. Late penalties may apply at the discretion of the instructor.
