## **Description**

We humans are, in the familiar ancient slogan, "rational animals". Yet there are systematic problems with the way we reason — routed in unconscious biases, fallacies, illusions, inconsistencies, misinformation and a multitude of intellectual vices.

The goal of this course is to help us get better at mitigating these cognitive shortcomings and, in turn, enhance our ability to reason. We pursue this aim with an eye towards forming more accurate beliefs and making better decisions.

Teaching methods will involve pre-prepared slides, with brief recordings, and online class discussions and exercises.



This fully online course will contain a mixture of synchronous and asynchronous learning methods. All synchronous (i.e., live Zoom) sessions will take place at the Tuesday and Thursday start times above. Zoom meetings will\_never last a full 3 hours. As an alternative, students will be given material to prepare for those sessions, asynchronously, at their own discretion. A weekly schedule (with Zoom links) will be made available on OWL. By the end of term, every committed student will know how to do four things:

- 1. categorize, diagram and assess arguments from virtually any discipline,
- 2. spot and, to some extent, mitigate common forms of human irrationality (e.g., biases, fallacies and inconsistencies), and the various harms they can cause,
- 3. look for good sources of information and distinguish these from bad sources
- 4. employ various techniques and principles for rationally updating their beliefs (SKILLS) (KNOWLEDGE, 1-4),

Students will also get opportunities to

5. construct intellectual rules or guidelines that improve their thinking and/or decisionmaking (PERSONAL DEVELOPMENT).

**Participation:** Good philosophy requires conversation. Consequently, in addition to prepared materials/ slides/recordings that you will review on your own time, this course contains weekly live sessions which will take place over Zoom. A successful participation grade requires taking active measures to advance the discussion. These include:

- (i) knowing and thoughtfully engaging the relevant materials (viz., the readings and/or prep slides listed on your weekly checklist),
- (ii) applying the tools and virtues associated with critical thinking,
- (iii) submitting written answers (1-2 sentences) Forum Qs, which will be released during the session. Forum Qs must be accessed— and answers must be submitted—within the small classroom window that is provided. No exceptions.
- (iv) respecting the College's conduct rules and any course-specific policies (see OWL), including our strict **no recording policy** (which helps protect student privacy and confidentiality).

*Note:* if you are working outside of Huron's local time zone, and are unable to attend our live online sessions, please note this in OWL's DropBox, <u>by May 16</u> by simply writing <u>"Opt-Out Request for Online Participation"</u> in the subject title. I would be pleased to fully accommodate you. Also, I will post slides corresponding to the tutorials.



**Podcast:** For this assignment, you will work, virtually, in small groups, including a moderator, that your instructor will assign. After receiving instructions and a group number, each group will record a video (or audio) podcast, over Zoom, and submit it for a grade. Detailed instructions will be provided via OWL.

**Rules assignment:** You will construct your own concrete rule(s) for mitigating bias and/or avoiding common fallacies. Detailed instructions, with a sample assignment, will be provided via OWL prior to the deadline.

**Exam:** To take place on **June 15, 2023** at 6:30 PM. Students will have 2 hours to complete — and properly submit — the exam, unless they formally qualify for extra time; in that case, it will automatically be provided. As this exam will be "open book", and written from home, its purpose is to test the student's understanding of course material and procedural knowledge of course techniques etc. As answers to such questions cannot be unreflectively pasted from the slides, advanced preparation is strongly recommended. The exam will likely have a mixture of longer answer questions and shorter questions, though nothing that a student could cut-and-paste from the slides. More details will be provided during our review session.

## Grading Information and Explanation of Grades

Each assignment will be accompanied by grading criteria and clear instructions. Students will be evaluated in accordance with how well they follow them. What follows is a university wide grade explanation:

## **Student Code of Conduct**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. ## Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence

## Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to

the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# b) <u>Medical Grounds</u> for assignments <u>worth 10% or more of final grade</u>: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <u>https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</u>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

## <u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
