## Course delivery with respect to the COVID-19 pandemic:

Although the intent is for this course to be delivered in-person, the changing COVID-19 landscape necessitates that some, and possibly all, of the course will need to be delivered online. While in-person classes are suspended, lectures will be delivered **asynchronously** (e.g., posted on OWL for students to view at their convenience). The grading scheme will not change. Any assessments affected will be conducted online as determined by the course instructor.

## **COURSE DESCRIPTION**

This course begins with the assumption that humans have moral duties and responsibilities toward one another. Given that assumption, what duties and responsibilities do they have when they are engaged in the production and transfer of goods and services, i.e., business. Some of the specific topics that will be discussed are: What is the purpose of the Modern Corporation? How are corporations and their individual members related in terms of moral responsibility? What responsibilities do corporations have to society at large? What is the ethical status of advertising?

#### LEARNING OBJECTIVES

The primary goal of this course is to help students improve their existing abilities to interpret and think critically about the materials they read. The primary means by which this goal will be accomplished are the lectures and the two essay assignments.

The second goal of this course is to introduce students to the ways in which the aforementioned skills have been applied to the ethical issues that arise in the realm of modern business. This goal will be accomplished by assessing students' understanding of these materials in four tests.

## **CLASS METHODS**

<u>80% Lecture</u> – The bulk of our class time will be devoted to ensuring that students understand the positions defended in the readings, and the issues to which those positions give rise.

<u>20% Discussion</u> – Students are expected to attend class having completed the scheduled readings, prepared to discuss each.

## **REQUIRED TEXTS**

All readings and lectures will be made available on OWL as the course proceeds.

#### METHOD OF ASSESSMENT

50% - two tests, worth 25% each 50% - two 1100 – 1300 word essays, worth 25% each\*

\* Late papers will be assessed a 5% penalty for each day that they are late to a maximum of 10 days or 50%. No papers will be accepted after the last day of classes, i.e., Friday April 8<sup>th</sup>, 2022.

## CLASSROOM MASK POLICY

## **Mandatory Use of Masks in Classrooms**

## **Pandemic Contingency**

In the event of a COVID-19 resurgence during the course that necessitates the course delivery moving away from face-to-face interaction, all remaining course content will be delivered entirely online, typically using a combination of synchronous instruction (i.e., at the times indicated in the timetable) and asynchronous material (e.g., posted on OWL for students to view at their convenience). Any remaining assessments will also be conducted online at the discretion of the course instructor. In the unlikely event that changes to the grading scheme are necessary, these changes will be clearly communicated as soon as possible.

#### **Statement on Use of Electronic Devices**

It is not appropriate to use electronic devices (such as, but not limited to, laptops, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

#### Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is **48 hours or less** and the other conditions specified in the Senate policy at

Students whose absences are expected to last **longer than 48 hours**, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has

already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation. #### Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, and if the student has exceeded the maximum number of permissible Self-Reported absences, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# (b) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email huronsss@uwo.ca.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation where the conditions for a Self-Reported Absence have not been met, including where the student has exceeded the maximum number of permissible Self-Reported. All consideration requests must include a completed <a href="Consideration Request Form">Consideration Request Form</a>. Late penalties may apply at the discretion of the instructor.
