2.0. CALENDAR DESCRIPTION

A research oriented course that focuses on the experiments and methodology that lead to our current understandings of mammalian sensation and perception.

Understanding of the introductory foundations of research and perception will be gained through practical experience (in-class experiments) in the various sensory modalities (i.e. Vision, Audition, Somatosensation, etc.).

3 lecture/seminar hours; 0.5 course

Note 1: Unless you have either the prerequisites for this course or written special permission to enroll, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

3.0 COURSE OBJECTIVES

By the end of this course, students should have:

- a broader understanding of concepts in sensation and perception
- a working knowledge of the research paradigms used in sensation and perception research
- an understanding of the use of converging evidence in the building of theories

4.0 DESCRIPTION OF CLASS METHODS

This course will be predominately lecture-based, but will also include in-lecture demonstrations and experiments that will investigate the basic processes in human sensation and perception. There will be three 'lecture' hours per week which will be used for both lectures and experiments/demos. Exams will assess students' basic conceptual and functional knowledge of both lecture and textbook material, as well as the methodological paradigms and findings resulting from the experiments/demos. Writing assignments will also be utilized to assess students' understanding of the materials/methods explored.

5.0 REQUIRED TEXTS

Assigned readings will be assigned as needed on a week-to-week basis and made available on the course website. These readings, along with lecture materials will be covered in the exams. Please note that most of the material for this course will come from lectures, therefore regular class attendance is highly recommended.

** Students at Huron University College should consider a grade in the range from 75-79 to be evidence of satisfactory performance in a 3000-level Psychology course. Grades in the A (80-90%) range will only be awarded for performance that is demonstrably superior to the third or fourth-year standard associated with the Major or Minor modules. A grade of A+ (90-100%) will only be awarded rarely and only for work that is exceptional.

6.2 Exams

There are two, 2-hour term tests (exams), which when combined, determine 70% of the final grade in the course. All exams will be written during a scheduled 48-hour period via OWL-Tests & Quizzes (See dates in 6.1 and 7.0). Students may log into their exam(s) at any point during these 48-hour periods. Once a student begins an exam, they will only have 2 hours in which to select/construct their answers and submit the exam. Students should select an exam start time that allows for the completion of the exams within the 48-hour period.

Exams are non-cumulative and each test covers approximately one half of the course material. Exams will be composed of multiple-choice, fill-in-the-blank, diagram, briefanswer and 1-page "essay-style" questions based on the assigned readings and lecture materials/discussions. Following the failure of a student to write an exam and acting on advice from the Academic Advising Office to provide relief (based on medical and/or non-medical grounds), we will allocate the weight devoted to that exam equally to the remaining graded components. Otherwise the grade recorded will be zero. Documentation for missed term tests must be submitted to the Academic Advising Office in a timely manner. The grades for the February exam and paper will be posted on owl.uwo.ca. Students may review their exams via Zoom meeting with their professor

during a scheduled meeting. All exam materials will be retained by the Psychology Department.

6.3 Lab Activities

There will be an assortment of lab activities to be submitted and/or performed each week (approximately). These activities will range from data analysis results (ANOVA's, Correlations, etc.) to small "at-home" research demonstrations. These activities will constitute 10% of the final grade and will be due by the beginning of the Tuesday lecture following their issuance. If students are unable to attend the live Zoom lectures due to timezone differences, then it is expected that these students watch the recorded lecture on Stream as soon as possible, so as to be able to submit their activity results on time.

6.4 Research Report

There will be one full experimental paper (in APA format) worth 20% of the final grade and will be due April 6th. This research report will be based on the methods and findings of the term project which will begin on Feb. 11th.

Statement Regarding Grades in Psychology at Huron University College

Students at Huron University College should consider a grade in the range from 70-74 to be evidence of satisfactory performance in a 2100-level Psychology course. Grades in the B+ (75-79) or A (80-89%) ranges will only be awarded for performance that is demonstrably superior to the second-year standard associated with the Major or Minor modules. A grade of A+ (90-100%) will only be awarded very rarely and only for work that is truly exceptional.

Prerequisite and Antirequisite Information

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enrol in it without them, you may be removed from this course and it will be deleted from your record. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

Conduct of Students in Classes, Lectures, and Seminars

Turnitin.com

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (https://www.turnitin.com/).

Computer-Marked Tests/exams

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

Clickers

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic_policies/appeals/Academic_Consideration_for_absences.pdf are met.

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting or medical of extenuating circumstances:

- Students will be allowed a maximum of two self-reported absences between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of
 duration, will require students to present a <u>Student Medical Certificate (SMC)</u>, signed by
 a licensed medical or mental health practitioner, detailing the duration and severity of
 illness, or appropriate documentation supporting extenuating circumstances to the
 Academic Counselling unit in their Faculty of registration no later than two business days
 after the date specified for resuming responsibilities.

- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors no later than 24 hours after the end of the period covered by the Self-Reported Absence form, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

Policy on "Academic" Accommodation - Medical / Non-Medical Grounds

(a) <u>Medical Grounds</u> for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email <u>huronsss@uwo.ca</u>.

University Senate policy, which can be found at, https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_medical.pdf, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will

be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed <u>Accommodation Request Form</u>. Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
