# 2. COURSE DESCRIPTION

This course covers the history, methodology, and content of the study of personality and individual differences. Topics that will be covered in the course include an introduction to personality theories, an examination of frequently studied personality and individual

difference variables, and a consideration of current personality research and assessment methods.

#### 3. COURSE LEARNING OUTCOMES

Throughout the course, students will develop knowledge, understanding, and the ability to critically evaluate personality-relevant material:

- ✓ PERSONALITY THEORIES: By the end of this course students will be able to discuss, compare, and critically examine major personality theories and how they were developed, as well as how they are relevant to modern society and social concerns.
- ✓ PERSONALITY TRAITS: By the end of this course students will understand and be able to compare and contrast commonly assessed personality traits and individual difference variables, and will also be able to discuss intrapersonal and interpersonal outcomes associated with these variables.
- ✓ PERSONALITY RESEARCH: By the end of the course students will have a comprehensive understanding of how personality research in psychology is conducted, and be able to compare various personality assessment methods and personality-relevant research designs.
- ✓ REAL WORLD APPLICATIONS: By the end of this course students will be able to understand how classroom material applies to real world outcomes and how classroom material connects to life experiences.

#### 4. DESCRIPTION OF CLASS METHODS

**LECTURES:** The course format will consist of live online lectures (i.e., synchronous lectures) hosted every week on Mondays and Wednesdays via Zoom. Lectures will run from 1:30-4:30pm EDT.

Zoom is a video conferencing service supported by Western University; therefore, every Western student has free access. Before each class, I will post a Zoom link on OWL, and students will click on that link to join the Zoom meeting and listen and participate in the lecture. There are no labs or tutorials. Zoom lectures will not be recorded.

# 6. METHODS OF EVALUATION

**Midterm Exam: 25%** (**Due:** May 31, 2023 at 11:55pm)

Final Exam: 40% (Due: During the Final Exam Period)

Brief Research Proposal: 25% (Due: June 21, 2023 at 11:55pm)

Online Activities: 10% (Due: Throughout the course)

Students at Huron University College should consider a grade in the range from 70-74 to be evidence of satisfactory performance in a 2100-level Psychology course. Grades in the B+ (75-79) or A (80-89%) ranges will only be awarded for performance that is demonstrably superior to the second-year standard associated with the Major or Minor modules. A grade of A+ (90-100%) will only be awarded very rarely and only for work that is truly exceptional.

#### Midterm Exam & Final Exam (Total Worth: 65%)

This course contains two exams: Midterm Exam & Final Exam. Both exams will be **open-book**, **take-home** format (i.e., asynchronous). Both exams will contain short-answer and long-answer questions. Both exams will cover the lecture units leading up to that exam session and are designed to be non-cumulative. Please note that take-home format exams are not considered traditional exams.

The Midterm Exam and Final Exam are designed to be completed in 3 hours or less, however I have provided an <u>almost 24-hour window</u> for students to complete the exams (to accommodate any time zone differences, work-life conflicts, or any other issues).

- (1) <u>Midterm Exam</u>: can be downloaded, worked on, and submitted between 12:00am and 11:55pm EDT on May 31, 2023.
- (2) **Final Exam**: check the Exam Schedule/Class Announcements for the date and time of the Final Exam.

Students who need to miss an exam due to medical or compassionate reasons should follow the appropriate accommodation procedures.

Due to recent advances in technology, written responses to exams can only contain information that comes from what was discussed during lectures, the lecture slides, and the course textbook. Outside information (i.e., information that does not come from lecture content or the textbook) cannot be used to answer exam questions, and exam questions must be completed independently and written using your own words (you will be asked to submit the exam through plagiarism software). Any violations will result in grading penalties.

#### **Brief Research Proposal (Total Worth: 25%)**

This brief research proposal (4 pages double-spaced in length) will give students the opportunity to develop a research study idea in Personality Psychology. This exercise encourages students to start becoming creators of knowledge in psychology.

For the research proposal, students will be asked to come up with their own idea for a Personality Psychology research study. Students will be asked to choose a personality variable(s) that interests them and develop a research study idea using that variable(s).

A research proposal rubric outlining the marking scheme will be provided to students. It is important that the research proposal is an original piece of writing and uses proper referencing/citations (you will be asked to submit the research proposal through plagiarism software).

#### Online Activities (Total Worth: 10%)

Online activities (OAs) provide creative ways of engaging with classroom content. Each OA is worth 2% of your grade. For each OA, students will be given a discussion question or a brief task, and they will be asked to write a short response.

Students are required to participate in <u>5 Online Activities</u> throughout the course (worth 2% each). They can choose which OA to participate in, however only the first five completed OAs will be graded. However, after participating in all five OAs, students can participate in one extra OA to replace their lowest grade. Please ensure you have properly completed five OAs before the end of term, as there are no make-up OAs. OAs will be graded (assigned a grade out of 2) according to the quality of the OA response and held to an appropriate average. A grading rubric will be provided to students.

OAs will become available on OWL after class each Monday and Wednesday for Lectures 1 through 8. Students will have the rest of the week to work on the OA(s) they chose, and they will be due Sunday at 11:55pm on that given week.

## 8.0 Academic Policies

# Statement Regarding Academic Accommodation in Psychology at Huron University College

In the Department of Psychology at Huron, courses are structured to allow students as much flexibility as possible. In the event of an acute medical illness or other personal emergency, students must request academic consideration as per Western Academic Senate Policy. The instructor must indicate on the course outline how accommodations are granted and arranged.

Student requests for academic consideration/accommodation for missed work must be submitted in a timely manner, typically no more than 48 hours after the missed evaluation. Requests submitted more than 48 hours after the missed evaluation will normally require a formal recommendation from an Academic Advisor.

For missed coursework worth less than 10% of the overall grade in a course, students should contact the instructor in writing as soon as possible to arrange for accommodation. In cases where accommodation is granted, the instructor will inform the student in writing what accommodation will be granted (e.g. makeup test, reweighting missed evaluation, accept late assignment).

For missed coursework worth 10% or more of the overall grade in a course, students must contact their home faculty Academic Advising office with appropriate documentation (at Huron, this is Huron's Academic Advising Office; if you are a student at a different campus, contact your academic advisor at your home campus).

In the Department of Psychology, if accommodation is granted, students will typically be granted an extension of 48 hours for written essays and reports from the time when accommodation is granted in writing, unless otherwise discussed with the course instructor. The typical accommodation for missed tests will be reweighting of the course grade, unless otherwise discussed with the course instructor. Instructors may request further documentation to approve accommodations.

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. #### Statement on Use of Electronic Devices

It is not appropriate to use electronic devices (such as, but not limited to, laptops, tablets, cell phones) in the classroom for non-classroom activities. Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

#### Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### Academic Consideration for Missed Work

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

## Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad

outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

<u>b)</u> <u>Medical Grounds</u> for assignments <u>worth 10% or more of final grade</u>: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at: <a href="https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf">https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf</a>.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

<u>c)</u> Consideration on <u>Non-Medical</u> Grounds: Consult Huron Support Services/Academic Advising, or email <u>huronsss@uwo.ca</u>.

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
