Course Description:

Climate Change affects everyone, but some are affected more adversely than others. Moreover, the burdens of preventing or mitigating its effects can fall unevenly on different people, depending on factors like race and class. Many Indigenous, environmentalist, anti-racist, feminist and labour movements propose to view these issues through the lens of climate justice. What is climate justice? How might it impact the law, public policy, and social movements?

In this course, we explore the theme of climate justice by delving deeply into three perspectives: (1) a militant anti-capitalist perspective, as proposed by Andreas Malm, in his provocatively named book, 'How to Blow Up a Pipeline'; (2) an Indigenous decolonize perspective proposed by Anishinaabe philosopher Kyle Powys Whyte, in several articles; and (3) a democratic-socialist perspective proposed by Kate Aronoff, Alyssa Battistoni, Daniel Aldana Cohen, and Thea Riofrancos in their book, 'A Planet to Win: Why We Need a Green New Deal.'

Learning Outcomes:

The readings, lectures, and class discussions should prepare students to evaluate and apply political and philosophical perspectives on climate justice.

Students should be able to think in sophisticated ways about moral and strategic issues in climate politics today.

Students should be able to carefully weigh considerations of social justice, democratic legitimacy, ecological sustainability, and public welfare, and to articulate verbally and in writing the implications of these and other values for the assessment of particular perspectives and policy proposals for climate justice.
