Course Description:

The aim of this course is to introduce students to both, the methodological foundations of comparing political structures, processes and systems, and the critical analysis of states and nations located in global 'south' and the global 'north'. Students will, therefore, strive to understand 'how' comparative political analysis takes place, and to understand 'what' the subjects of analysis within comparative political analysis are. The thematic foci of this course will be on methods, regimes, institutions, the nation, identity, nation-building, ethnicity and nationalism, political economy, capitalism, and civil society. The lectures and discussions will further be animated by discussions and analyses of state structures in the United States, the United Kingdom, France and Germany, along with Russia, China, India, Brazil, Nigeria and South Africa, among others.
