Effective September 1, 2024

Admission requirements: 60% average in 4.0 credits, 1.0 must be an essay designate.

Below is additional information about the AESL modular structure as a resource to complement the Western Calendar. If there are any discrepancies, the Western Calendar supersedes this document. The highlighted courses are proposed additions which must complete the required stages of approval pursuant to Western policy and governance. If/once they are approved, they will be reflected in the Western Calendar AESL module description, potentially as early as spring 2024.

A maximum of 1.0 credits can contribute to meeting the degree requirements of two different modules (i.e. “double count”).
