**Prerequisite(s):** 0.5 Centre for Global Studies course at the 1000-1099 level, or permission of the Centre for Global Studies.

### **CGS 3528 Non-Hegemonic Food Economies**

The calendar description for this course reads as follows: “An examination of the persistence, resurgence, and radicalization of modes of producing and consuming food in a context of hyper-capitalized and globalized food regimes. This course examines food-based economies foundational to a variety of social movements aimed at establishing and re-establishing forms of local and relational autonomy.”

Centre for Global Studies students will immediately recognize this orientation, to focus on people’s activities and endeavors under less-than-sufficient circumstances, to move the innovation, creativity and insight generated in the life of the community into the foreground. In this case, we are drawing our focus on activities that provision households and the networks they sustain and are sustained by. We will examine food provisioning as a medium to produce strength under conditions that are often threatening.

### **Learning Objectives**

Students will exercise close reading skills, conduct interdisciplinary research, perform an original analysis of cases and practice skills of listening and responding in a seminar setting. Overall these are advanced scholarly skills suitable to rigorous interdisciplinary study.

### **Class Methods**

Your course materials will be readings, discussion questions assigned for each reading, and some lectures that we will discuss in weekly meetings (9:30-12:30 each Wednesday). During weeks 1-7 we will have weekly discussions on readings and topics announced on our OWL page, and during weeks 8-12 we will host student presentations. Each presenter will assign a reading, and I will then assign a sub-group of students to do that reading and prepare a question for the presenter. (See ‘evaluation’ below for a description of this interlocutor role)

### **Evaluation**

Attendance 10% one point deduction for each unexcused absence

Participation 10% speak up, answer, and ask questions

Presentation (to the entire class, to be scheduled) 15%

Presentation Interlocutor (you do a reading and ask a question) 5%

Bibliography Due February 9 15% (I will email you a response as soon as I am able)

### *Attendance*

This is straightforwardly that your 10 points are reduced by 1 point for each unexcused absence.

### *Participation*

Each week you will find a reading and a set of discussion questions on OWL under our 'Lectures' tab, each week numbered as in the work schedule below. Some weeks' readings are very long, so please check well in advance of class and give yourself sufficient time to prepare in advance for class. Participation grades will also be reduced by 1 point for each unexcused absence, but also for not participating at all.

### *Presentation*

You will give a 15-20 minute presentation supported by a 3-4 slide presentation to the entire class. Each presenter will have five assigned interlocutors, and each will do a reading you assign and ask a question or make a comment about your project. It sounds weird on paper, but it's a way for us to practice being in a seminar together taking advantage of what Zoom has to offer. You will be required to submit your slides to me \*no later than\* 8:30 am on the day of your presentation, AND you will be required to submit a reading to me \*no later than\* one week in advance of your presentation date. Sorry for all the \* there, but, you get it.

### *Presentation Interlocutor*

As you have already heard (see above, ha ha) each presentation has an accompanying assignment for your classmates, which is to act as interlocutors. To prepare for that role, each week you will be assigned to a presenter and to do the reading they assign. Your role will be to ask a question based on the reading and the presentation, or to contribute a statement about how this case advances our understanding of the importance of the core thesis of the course. It's all very exciting.

### *Case Study Bibliography*

Please see the description of the case study assignment on our 'resources' page to choose your topic and schedule a zoom appointment with me to discuss your paper topic as early as possible. Your bibliography assignment is more than list of resources. It should be a carefully selected set of readings that are specific studies of the case you are examining in your case. This means nothing extraneous (like an encyclopaedia entry or news story) or unscholarly, nothing you cannot access, even though you might be looking at such sources as part of your work on the project. A reasonable number of sources is fifteen, but if you find twenty or one hundred, that is

fine too. What matters is that it demonstrates the work you have done to get this project underway.

And, please use the Research Guides that your professors in the Centre for Global Studies have created for you. They make a huge difference and save you from the dreaded (and absolutely unhelpful) Google Scholar (dun dun dun). See the link on OWL please.

Please note you are also required to present this bibliography in Chicago Author-Date style, as you will be using Chicago Author-Date citations in the text of your paper. See this link for sample citations and samples of how to cite your resources in your paper:

### *Case Study Outline*

This assignment is a very detailed account of the argument you are making in your paper (what is the case, how is it non-hegemonic, what might it tell us about the future), and must include specific details, each cited, from your research. A strong assignment will reference many sources, even give quotations (even if they are long) to demonstrate you are synthesizing your research around the case you are making in the paper.

### *Case Study*

This is a brief paper, 2000 words, structured as described in the brief 'Case Study Assignment' document you will find on OWL.

## **Appendix to Course Outlines: Academic Policies & Regulations 2020 - 2021**

### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enrol in it without them, you may be removed from this course and it will be deleted from your record. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

### **Conduct of Students in Classes, Lectures, and Seminars**

Membership in the community of Huron University College and Western University implies acceptance by every student of the principle of respect for the rights, responsibilities, dignity and well-being of others and a readiness to support an environment conducive to the intellectual and personal growth of all who study, work and live within it. ### **Academic Integrity: Importance and Impact**

Being at university means engaging with a variety of communities in the pursuit and sharing of knowledge and understanding in ways that are clear, respectful, efficient, and productive. University communities have established norms of academic integrity to ensure responsible, honest, and ethical behavior in the academic work of the university, which is best done when sources of ideas are properly and fully acknowledged and when responsibility for ideas is fully and accurately represented.

In the academic sphere, unacknowledged use of another's work or ideas is not only an offence against the community of scholars, it is also an obstacle to academic productivity. It may also be understood as fraud and may constitute an infringement of legal copyright.

A university is a place for fulfilling one's potential and challenging oneself, and this means rising to challenges rather than finding ways around them. The achievements in an individual's university studies can only be fairly evaluated quantitatively through true and honest representation of the actual learning done by the student. Equity in assessment for all students is ensured through fair representation of the efforts by each.

Acting with integrity at university constitutes a good set of practices for maintaining integrity in later life. Offences against academic integrity are therefore taken very seriously as part of the university's work in preparing students to serve, lead, and innovate in the world at large.

A university degree is a significant investment of an individual's, and the public's, time, energies, and resources in the future, and habits of academic integrity protect that investment by preserving the university's reputation and ensuring public confidence in higher education.

**Students found guilty of plagiarism will suffer consequences ranging from a grade reduction, to failure in the course, to expulsion from the university. In addition, a formal letter documenting the offence will be filed in the Dean's Office, and this record of the offence will be retained in the Dean's Office for the duration of the student's academic career at Huron University College.**

### **Turnitin.com**

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<https://www.turnitin.com/>).

### **Computer-Marked Tests/Exams**

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

### **Clickers**

Personal Response Systems (“clickers”) may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else’s clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

### **Requests for Academic Consideration Using the Self-Reported Absence Form**

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a **maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a **Student Medical Certificate (SMC)**, signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

### **Policy on “Academic” Accommodation - Medical / Non-Medical Grounds**

- (a) **Medical Grounds** for assignments *worth 10% or more of final grade*: Go directly to Huron Support Services/ Academic Advising, or email [huronsss@uwo.ca](mailto:huronsss@uwo.ca) .

University Senate policy, which can be found at,

[https://www.uwo.ca/univsec/pdf/academic\\_policies/appeals/accommodation\\_medical.pdf](https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_medical.pdf) , requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the “home faculty” is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other

supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

**(b) Accommodation on Medical Grounds for assignments worth *less than 10%* of final grade: Consult Instructor Directly**

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may not collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

**(c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising**

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed [Accommodation Request Form](#). Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
