Course Description:

This course introduces students to the literary theory of ecocriticism and explores the representation of nature and environment in Chinese literature and film in contemporary era of industrialization, modernization, and urbanization. The course focuses particularly on the relationship that various Chinese communities have with the natural world and the influence of politics, ethnicity, gender, class on such relationship. The course is taught in Chinese.

Learning Objectives:

By the end of this course, students will be able to

- Outline the major developments in ecocriticism in Chinese literary and cultural studies;
- Identify some important writers, film directors, and their works that explore the environmental issues and raise public awareness about eco problems in China;
- Understand social, political, economic factors that influence environment through the lens of literary and visual representation;
- Develop analytical skills and critical thinking abilities in studying Chinese literature and film from the perspective of ecocriticism.

Textbooks and Other Required Resources:

Readings will be provided on OWL course website.

Class Methods:

Classes are usually composed of a lecture and a discussion session led by students. Discussion will be based on the assigned readings. Students are required to participate actively in the discussion.

Attendance and Participation

Attendance and participation do not simply mean that you attend all classes, coming to class on time and staying until the end. It is most important that you read the texts and come to class prepared. You must actively participate in the discussion and interact with the instructor and your fellow students.

Presentation and Report

Students will sign up for the session that they plan to do their presentation. The presentation topics will be available on a first-come, first-served basis. You should prepare a short oral presentation for 10 minutes and one or two questions for discussion. You are required to submit a report of your presentation and discussion questions (including a hard copy and an electronic copy) one week after your presentation. Specific instructions for the presentation and report will be provided in class.

Tests

The mid-term test will take place in class on **Feb. 12**. It is three hours in length and covers lectures and readings in the first five sessions. The final exam will be scheduled during the exam period. It is three hours and covers lectures and readings after the mid-term test. No use of reference materials or electronic devices is permitted for both tests. Exam format will be given in class prior to the exam.

Term Paper

Students will write a research paper of at least 3000 words based on the proposal on text(s) different from that of their presentation. Please provide a word count at the end of your paper. You must consult scholarly books and articles and not limit your research to Internet sources. All the primary and secondary sources must be appropriately cited in the paper and listed in your bibliography in given format. No form of plagiarism or academic dishonesty will be tolerated. The paper should be typewritten and double-spaced with a clearly defined thesis statement supported by relevant evidence. The hard copy of the essay must be submitted at the beginning of the class. Essays submitted after 5:30 pm on **April 1** will be counted one day late. The electronic copy of the essay must be uploaded to OWL on April 1 as well. Specific instructions for the term paper will be provided in class.

Special Instructions:

- 1. Once you sign up your presentation, you cannot change your topic without the permission of the instructor. There will be no grade given in the case of no-show without prior notice.
- There is a penalty for late submission of the hard copy and electronic copy of presentation report and term paper. Penalty is 10% for each calendar day to a total of three days. Assignments more than three days late will not be accepted. Late assignments should be submitted to the drop box located outside the Administrative Assistants' Office (A116).
- 3. There will be no make-up tests for the missed presentation and mid-term examination. Failure to complete your presentation or write the midterm exam will result in a grade of zero without proper documentation. A student who misses a presentation or test must provide documentation to the counseling office (not the professor). If this documentation is accepted as a valid reason for missing a presentation or test, then (**and only then**) the weight of the presentation will be reallocated to the report and the weight of missed test will be reallocated to the final exam. This is the only method of accommodation for missed presentation/test that will be used in this course.

Appendix to Course Outlines: Academic Policies & Regulations 2019/2020

Prerequisite and Antirequisite Information

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enrol in it without them, you may be removed from this course and it will be deleted from your record. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

Conduct of Students in Classes, Lectures, and Seminars

Membership in the community of Huron University College and Western University implies acceptance by every student of the principle of respect for the rights, responsibilities, dignity and well-being of others and a readiness to support an environment conducive to the intellectual and personal growth of all who study, work and live within it. Turnitin.com

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for a detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between Western University and Turnitin.com.

Computer-Marked Tests/exams

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

Clickers

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

Academic Consideration for Missed Work

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). The Student Medical Certificate is available online at https://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf .

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. **Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.**

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

The following conditions are in place for self-reporting of medical or extenuating circumstances:

a. students will be allowed **a maximum of two self-reported absences** between September and April and one self-reported absence between May and August;

b. any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a **Student Medical Certificate** (**SMC**), signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities. Please see section 4 below for more details.

c. The duration of the excused absence will be for a maximum of 48 hours from the time the Self-Reported Absence form is completed through the online portal, or from 8:30 am the following morning if the form is submitted after 4:30 pm;

d. The duration of the excused absence will terminate prior to the end of the 48 hour period should the student undertake significant academic responsibilities (write a test, submit a paper) during that time;

e. The duration of an excused absence will terminate at 8:30 am on the day following the last day of classes each semester regardless of how many days of absence have elapsed;

f. Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term;

g. Self-reporting **may not be used** for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.

h. students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

<u>Policy on "Academic" Accommodation - Medical / Non-Medical Grounds</u> (if absence is not self-reported)

(a) <u>Medical Grounds</u> for assignments *worth 10% or more of final grade*: Go directly to Huron Support Services/ Academic Advising, or email <u>huronsss@uwo.ca</u>.

<u>https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_medical.pdf</u>, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(c) <u>Non-Medical Grounds</u>: Consult your Instructor directly.

Where the grounds for seeking accommodation are not medical, the student should contact the instructor directly. Late penalties may apply at the discretion of the instructor. Apart from the exception noted below, academic advisors will not be involved in the process of accommodation for non-medical reasons.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
