Course Description:

This is a survey course that serves as an introduction to modern American history. At the end of the Civil War, Americans were left with many questions about the meaning of the bloody conflict. Two of the central questions were: what was freedom, and who deserved it? These questions—and various people's answers to them—became driving forces for change (both positive and negative) from the 19th century and into the 20th. Beginning in 1865, this course will delve into American history, keeping that central theme of freedom in mind—to whom it was granted, to whom it was denied, and how the definition of freedom changed over time. Students will also interpret a variety of primary and secondary sources in order to think critically about the ways in which stories of American freedom are told.

This course will begin in the late 19th century and end in the late 20th century. The course will proceed chronologically with special attention paid to political, social, and intellectual history, and their interplay with the ever-shifting constructs of race and gender.

Course Learning Objectives:

By the end of the course, you will have made progress toward meeting the course learning objectives. Assignments tailored to meet each objective are noted in parentheses. This course is designed to help students:

- 1. Identify and interpret themes and patterns throughout modern American history. (discussion, book review, research paper and final exam)
- 2. Find and analyze primary sources. (book review, research paper)
- 3. Learn valuable writing skills such as how to form an argument and support it with historical evidence. (book review, research paper)
- 4. Question and evaluate historiographical debates among U.S. historians and how these interpretations shape cultural narratives. (discussion, book review, research paper, final exam)

5. Engage in the larger question about the relevancy of this history to the contemporary world and how this history shapes our own understanding. (discussion, book review, final exam)

Required Readings:

(All books are available through the University book store) Eric Foner, *Give Me Liberty! Volume 2* (Seagull Edition) Eric Foner, ed Voices of Freedom, Volume 2 David Grann, Killers of the Flower Moon: The Osage Murders and the Birth of the FBI Anne Moody, Coming of Age in Mississippi

In addition, other brief readings may be assigned as preparation for class discussion. These will be available on the course OWL site well in advance.

Assignments and Assessments:

In-Class Participation 25%Critical Book Review 20%Research Paper25%Final Exam30%

Detailed guidelines on all written assignments are on a separate handout posted to OWL, and will be discussed in class well in advance of deadlines.

Participation:

Participation will take place in the form of class discussion in the second half of each class. Our focus in most class discussions will be on the books *Give Me Liberty!* and *Voices of Freedom*. The text book *Give Me Liberty!* provides vital background information for your lectures. It is important that you read it in connection with class each week. The main focus of our in-class discussions will be the material in *Voices of Freedom*. It is very important important to make sure that the assigned reading materials are read and that students come to each class prepared to discuss them.

Participation in the course is mandatory. While some participation marks will be given for attendance (50%), full marks will only be awarded to those engaging in discussion and actively contributing to the discussion portion of class. Active participation may take different forms at the instructor's discretion. In some classes, students will be split into groups for discussion, while in others discussion will involve engagement with the full class group, and there will be times where brief written responses to the day's discussions will be required. This should allow a variety of ways in which students can participate in class discussion.

Critical Book Review:

Students will write a 2 to 3 page book review on David Grann's *Killers of the Flower Moon: The Osage Murders and the Birth of the FBI*. All papers are to be written using Chicago style formatting using endnotes or footnotes. More detailed instructions to follow. **Due: October 16 electronically on the course OWL website at 12:00pm noon.**

Research Paper:

Students will write one 7-10 page research paper on a topic of their choosing. These topics **must** be approved by the instructor at least two weeks prior to the deadline. Failure to obtain instructor approval for a topic within the indicated timeline will result in a 5% penalty for the assignment. All papers are to be written using Chicago style formatting using endnotes or footnotes. More detailed instructions to follow.

Due: December 6 electronically on the course OWL website at 12:00pm noon.

Course Policy on Assignment Submissions and Late Assignments:

Each assignment is due at the time listed above (in this case October 16 at 12:00pm noon, and December 6 at 12:00pm noon, respectively). This means that each assignment must be submitted **before** 12:00pm noon on the day it is due. ALL assignments must be submitted as a Word document (.doc, .docx). All assignments **must** be uploaded to the course OWL website. Failure comply with these instructions will result in late mark deductions until the assignment is uploaded.

<u>Additionally</u>: DO NOT upload assignments as a PDF or any other format—the <u>only acceptable</u> <u>formats are Word files, specifically .doc and .docx</u>. Assignments uploaded in the incorrect file type format will be considered <u>late</u> and will accrue late penalties until uploaded in the required file type format (only .doc or .docx).

All late submissions of assignments will lose <u>five percent (5%) per day</u>, starting on the due date, and including weekends as two separate days.

Detailed guidelines on all written assignments will be provided on a separate handout posted to OWL and be discussed well in advance of deadlines.

Appendix to Course Outlines: Academic Policies & Regulations 2019/2020

Prerequisite and Antirequisite Information

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. Unless you have either the requisites for this course or written special permission from your Dean to enrol in it without them, you may be removed from this course and it will be deleted from your record. If you enrol in this course despite having already taken an antirequisite you may be removed from this course and it will be deleted from your record. Removals for these reasons may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites or for having already taken the antirequisites.

Conduct of Students in Classes, Lectures, and Seminars

Membership in the community of Huron University College and Western University implies acceptance by every student of the principle of respect for the rights, responsibilities, dignity and well-being of others and a readiness to support an environment conducive to the intellectual and personal growth of all who study, work and live within it. Upon registration, students assume the responsibilities that such registration entails. The academic and social privileges granted to each student are conditional upon the fulfillment of these responsibilities.

Technology

Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

Attendance Regulations for Examinations

A student is entitled to be examined in courses in which registration is maintained, subject to the following limitations:

1) A student may be debarred from writing the final examination for failure to maintain satisfactory academic standing throughout the year.

2) Any student who, in the opinion of the instructor, is absent too frequently from class or laboratory periods in any course will be reported to the Dean of the Faculty offering the course (after due warning has been given). On the recommendation of the Department concerned, and with the permission of the Dean of that Faculty, the student will be debarred from taking the regular examination in the course. The Dean of the Faculty offering the course will communicate that decision to the Dean of the Faculty of registration.

Short Absences: If you miss a class due to a minor illness or other problems, check your course outline for information regarding attendance requirements and make sure you are not missing a test or assignment. Cover any readings and arrange to borrow notes from a classmate. Contact the course instructor if you have any questions.

Extended Absences: If you have an extended absence, you should contact the course instructor and an Academic Advisor. Your course instructor and Academic Advisor can discuss ways for you to catch up on missed work and arrange academic accommodations, if appropriate and warranted.

Statement on Academic Integrity

From these values flow principles of behaviour that enable academic communities to translate ideals to action." (CAI Fundamental Values Project, 1999).

Academic Integrity: Importance and Impact

A university is a place for fulfilling one's potential and challenging oneself, and this means rising to challenges rather than finding ways around them. The achievements in an individual's university studies can only be fairly evaluated quantitatively through true and honest representation of the actual learning done by the student. Equity in assessment for all students is ensured through fair representation of the efforts by each.

Acting with integrity at university constitutes a good set of practices for maintaining integrity in later life. Offences against academic integrity are therefore taken very seriously as part of the university's work in preparing students to serve, lead, and innovate in the world at large.

A university degree is a significant investment of an individual's, and the public's, time, energies, and resources in the future, and habits of academic integrity protect that investment by preserving the university's reputation and ensuring public confidence in higher education.

Students found guilty of plagiarism will suffer consequences ranging from a grade reduction to failure in the course to expulsion from the university. In addition, a formal letter documenting the offence will be filed in the Dean's Office, and this record of the offence will be retained in the Dean's Office for the duration of the student's academic career at Huron University College.

Turnitin.com

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for a detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between Western University and Turnitin.com.

Computer-Marked Tests/exams

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

Clickers

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

https://www.uwo.ca/univsec/pdf/academic_policies/appeals/accommodation_medical.pdf, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a

request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

(c) <u>Non-Medical Grounds</u>: Consult your Instructor directly.

Where the grounds for seeking accommodation are not medical, the student should contact the instructor directly. Late penalties may apply at the discretion of the instructor. Apart from the exception noted below, academic advisors will not be involved in the process of accommodation for non-medical reasons.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

The following conditions are in place for self-reporting of medical or extenuating circumstances:

a. students will be allowed **a maximum of two self-reported absences** between September and April and one self-reported absence between May and August;

b. any absences in excess of the number designated in clause a above, regardless of duration, will require students to present a **Student Medical Certificate** (**SMC**), signed by a licensed medical or mental health practitioner, detailing the duration and severity of illness, or appropriate documentation supporting extenuating circumstances to the Academic Counselling unit in their Faculty of registration no later than two business days after the date specified for resuming responsibilities. Please see section 4 below for more details.

c. The duration of the excused absence will be for a maximum of 48 hours from the time the Self-Reported Absence form is completed through the online portal, or from 8:30 am the following morning if the form is submitted after 4:30 pm;

d. The duration of the excused absence will terminate prior to the end of the 48 hour period should the student undertake significant academic responsibilities (write a test, submit a paper)

during that time;

e. The duration of an excused absence will terminate at 8:30 am on the day following the last day of classes each semester regardless of how many days of absence have elapsed;

f. Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term;

g. Self-reporting **may not be used** for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.

h. students must be in touch with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form**, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.
