# **Course Description:**

This course provides a critical survey of the social, economic, religious, and political experience of the Jewish people and their precursors from the biblical period until the Spanish Expulsion. The course will cover a wide variety of topics, but will focus on three principal themes: (1) how we know what we know about Jewish history; (2) the ways in which Jewish life was influenced by the cultures in which particular Jewish communities lived; and (3) the ways in which there is continuity and commonality among Jewish communities no matter the time and place of these communities.

# **Course Learning Objectives:**

Students who successfully complete this course will be able to:

- identify key events, persons, places, and works in Jewish history;
- relate these facts to the larger cultural and political contexts in which they took place;
- describe continuities in Jewish life regardless of region or time period;
- analyze primary sources and understand what they tell us about Jewish history;
- formulate clear and analytic arguments in written work and presentations based on primary and secondary sources.

## **Description of Class Methods**

Class methods will include short recorded lectures, weekly exercises on primary sources and issues, and class discussion. Students are expected to have completed the readings for each session before the session, to complete their weekly exercises on identifications and issues each week, and to participate in the forums on primary sources each week.

Grades will be based on weekly forums on primary sources, weekly exercises on identifications and issues, one exam, and two papers designed to develop students' ability to analyze primary documents and integrate them into broader historical narratives. A primary source will be suggested for each assignment. Student may choose a different primary source only with prior approval from the instructor. The primary text analyses will be a more in-depth analysis of the type done for the weekly exercises on primary sources. The papers are due on the schedule set forth below.

When you join the weekly class Zoom, have your textbook with you, along with any other readings assigned for that session.

For the weekly forums on primary sources, students will be assigned to a Team A or a Team 1. Team A will be responsible for teaching Team 1 about primary source A. Team 1 will be responsible for teaching Team A about primary source 1.

Starting with the second week of the course, on Thursday each week at 12:00 pm, the forum for each team will open with a posting of the primary source for that team. Working with their team, the students will post to the forum information and analysis of the primary source. Beginning Monday at 9:00 am and closing at 9:00 pm on Monday, the students from the other team will post questions about the first team's primary source to that forum. Questions will be addressed in the forums and in the weekly synchronous class session, a recording of which will be available on OWL following the session. The forum for the first week of the course will deal with an introductory topic and will be included in the grade for weekly forums on primary sources.

The weekly identification and issues exercises will be posted to OWL each week by Friday at 9:00 am. They must be completed by Tuesday at 10:00 am. Weekly identifications and issues exercises submitted after these deadlines will receive no credit.

Primary Source Analysis #1 is due Tuesday, October 6 at 9:00 am via OWL. Primary Source Analysis #2 is due Tuesday, November 10 at 9:00 am via OWL. The final examination will be posted to OWL on Dec. \_\_\_. It is due Dec. \_\_\_ via OWL. Please use your course materials to complete the questions.

The Primary Source Analyses must be typed, double-spaced, using 1" margins, and 12-point font. Each paper must be between 1,300 and 1,600 words.

Papers handed in late will be penalized one full letter grade if submitted within one week of the due date. Papers will not be accepted after that time. Exams will be taken as scheduled. Any exceptions will be pursuant to the Western Policy on Accommodation for Medical Illness.

#### **RULES AND REGULATIONS**

The History Department has specified that:

- 1. All written assignments are to be submitted electronically following your professor's instructions. Students are responsible for making sure they are familiar with each professor's policy on electronic submissions.
- 2. Footnotes, endnotes and bibliographies are to be prepared according to the Departmental Guide (which follows).
- 3. Late marks are calculated on the paper copy submitted to OWL Late penalties are calculated according to calendar day, including Saturdays.
- 4. In first and second year courses lateness will be penalized as follows: First day late -- 3 marks deduction. Each subsequent calendar day late -- 2 marks per day deduction.
- 5. Third and fourth year seminars will be penalized for lateness at the rate of half a grade (5%) per day.
- 6. No paper or seminar will be accepted if it is more than seven calendar days late.
- 7. Extensions will only be given for assignments **worth more than 10%** with medical documentation submitted through Academic Counseling.
- 8. Students must complete the written assignments worth more than 10% to pass essay courses. If the written assignments are not handed in, the default grade will be 48% or the cumulative average of the student, whichever is lower.

#### Guide to Footnotes and Bibliographies: Huron History Department

Footnotes have several purposes in a history paper:

- 1- They acknowledge your use of other peoples' opinions and ideas.
- 2- They allow the reader to immediately find your reference.
- 3- They give authority for a fact which might be questioned.

4- They tell the reader when a source was written.

Footnotes can appear either at the bottom of the page or collected together at the end of the essay where they are referred to as endnotes. The numeral indicating the footnotes should come at the end of the quotation or the sentence, usually as a superscript. <sup>1</sup>

A footnote gives four main pieces of information which are set off by commas in the following order:

- 1. Author (surname *after* initials or first name),
- 2. Title
  - o The title of a book is underlined or written in *italics*.
  - o The title of an article is put within quotation marks, followed by the periodical in which it was published, underlined or in *italics*
  - 3..Place and date of publication in parentheses (),
    - o A fuller reference will include the publisher after the place of publication.
    - o Article citations do not include the place of publication and publisher.
  - 4. Page number (including volume number if necessary)

## For example:

<sup>1</sup>J.M.S. Careless, Canada, A Story of Challenge (Toronto, Macmillan Co. of Canada, 1970), 207.

<sup>2</sup>Basil Davidson, "Questions about Nationalism", African Affairs 76 (1977), 42.

In subsequent references, a shorter reference can be used. It should include the author's last name, a meaningful short title, and page numbers. For example:

<sup>3</sup>Careless, *Canada*, 179-206.

Where the reference is *exactly* the same as the preceding one, the Latin abbreviation *ibid*. can be used; where it is the same, but the page number is different, use *ibid*., followed by the relevant page number. However, the short title form is preferable for subsequent references and the use of other Latin abbreviations such as *op.cit*. is not recommended.

#### Examples:

a) for a book by a single author: Author, title (place of publication: press, year), p#.

Elizabeth Wilson, *Shostakovich: A Life Remembered* (Princeton: Princeton University Press, 1994), 324.

<sup>&</sup>lt;sup>1</sup> They should be in Arabic, not Roman numerals or letters.

b) for an article in a book that has chapters by different people: Author, "title of chapter," in title of book, ed. editor's name (place of publication: press, year), total pages of article, page number you are referencing.

Elizabeth Heinemann, "The Hour of the Woman: Memories of Germany's 'Crisis Years' and West German National Identity," in *The Miracle Years: A Cultural History of West Germany*, 1949-1968, ed. Hanna Schissler (Princeton: Princeton University Press, 2001), 21-56, 34.

c) for an article in a journal, magazine, or newspaper: Author, "title of article," title of periodical, vol. #, issue # (year): total pages, the page you are referencing.

Gale Stokes, "The Social Origins of East European Politics," *Eastern European Politics and Societies* 1, 1 (1987): 30-74, 65.

d) for an old work that has been reissued: Try to find a way to include the original publication date somewhere. The easiest method is to use brackets.

Sigmund Freud, *The Interpretation of Dreams*. Trans. and ed. James Strachey (New York: Avon Books, 1965 [1900]), 175.

## **Bibliography**

All the works you consulted, not just those cited in the footnotes, should be included in the bibliography. You may be required to prepare an annotated bibliography, in which you comment on the contents, utility, or worth of each source. If so, make sure you understand what the instructor expects, in particular the length as well as the nature of each annotation.

Generally, list the sources in alphabetical order, by author. The format for a bibliography is similar to that for footnotes, except that the author's surname *precedes* the other names and initials, periods instead of commas are used to divide the constituent parts, publication data is not put in brackets, and pages numbers are not included except in the case of articles where the full page reference is necessary. For example:

Careless, J.M.S. *The Union of the Canadas. The Growth of Canadian Institutions* 1841-1857. Toronto: McClelland and Stewart, 1967.

#### **Prerequisite and Antirequisite Information**

Students are responsible for ensuring that they have successfully completed all course prerequisites and that they have not completed any course antirequisites. ## **Conduct of Students in Classes, Lectures, and Seminars**

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (https://www.turnitin.com/).

#### **Computer-Marked Tests/Exams**

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating.

## Clickers

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

#### **Academic Consideration for Missed Work**

Students who are seeking academic consideration for missed work during the semester may submit a self-reported absence form online provided that the absence is 48 hours or less and the other conditions specified in the Senate policy at

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/Academic\_Consideration\_for\_absences.pdf are met.

Students whose absences are expected to last longer than 48 hours, or where the other conditions detailed in the policy are not met (e.g., work is worth more than 30% of the final grade, the student has already used 2 self-reported absences, the absence is during the final exam period), may receive academic consideration by submitting a Student Medical Certificate (for illness) or other appropriate documentation (for compassionate grounds). All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

Students who have conditions for which academic accommodation is appropriate, such as disabilities or ongoing or chronic health conditions, should work with Accessible Education Services to determine appropriate forms of accommodation.

# Requests for Academic Consideration Using the Self-Reported Absence Form

Students who experience an unexpected illness or injury or an extenuating circumstance (48 hours or less) that is sufficiently severe to temporarily render them unable to meet academic requirements (e.g., attending lectures or labs, writing tests or midterm exams, completing and submitting assignments, participating in presentations) should self-declare using the online Self-Reported Absence portal. This

option should be used in situations where the student expects to resume academic responsibilities within 48 hours or less.

Please note the following conditions that are in place for self-reporting of medical or extenuating circumstances:

- Students will be allowed a maximum of two self-reported absences between September and April and one self-reported absence between May and August;
- Any absences in excess of the number designated in clause a above, regardless of duration, will
  require students to present a <u>Student Medical Certificate (SMC)</u>, signed by a licensed medical or
  mental health practitioner, detailing the duration and severity of illness, or appropriate
  documentation supporting extenuating circumstances to the Academic Counselling unit in their
  Faculty of registration no later than two business days after the date specified for resuming
  responsibilities.
- Self-reported absences will not be allowed for scheduled final examinations; for midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term.
- Self-reporting may not be used for assessments (e.g. midterm exams, tests, reports, presentations, or essays) worth more than 30% of any given course.
- Students must be in touch with their instructors no later than 24 hours after the end of the period covered by the Self-Reported Absence form, to clarify how they will be expected to fulfil the academic expectations they may have missed during the absence.

# Policy on "Academic" Accommodation - Medical / Non-Medical Grounds

(a) <u>Medical Grounds</u> for assignments worth 10% or more of final grade: Go directly to Huron Support Services/ Academic Advising, or email <u>huronsss@uwo.ca</u>.

University Senate policy, which can be found at,

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/accommodation\_medical.pdf, requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

https://www.uwo.ca/univsec/pdf/academic\_policies/appeals/medicalform.pdf.

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# (b) Accommodation on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly

When seeking accommodation on medical grounds for assignments worth less than 10% of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

## (c) Non-Medical Grounds: Consult Huron Support Services/ Academic Advising

Where the grounds for seeking accommodation are not medical (e.g. varsity sports, religious, compassionate, bereavement) the student should contact an academic advisor directly. All accommodation requests must include a completed <u>Accommodation Request Form</u>. Late penalties may apply at the discretion of the instructor.

Where a student seeks accommodation on non-medical grounds where confidentiality is a concern, the student should approach an academic advisor with any documentation available. The advisors will contact the instructor after the student's request is received, and will outline the severity and duration of the challenge without breaching confidence. The student will be informed that the instructor has been notified that significant circumstances are affecting or have affected the student's ability to complete work, and the student will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. Before denying a request for accommodation where documentation has been submitted to an academic advisor, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.
