#### 2.0 COURSE DESCRIPTION

Music, like language, is a universal phenomenon, found in every known culture. Yet, the scientific study of music is still in its infancy. While some prominent cognitive scientists have dismissed music as epiphenomenal, having no real consequence for how the human mind has evolved, this does not mean that music – as a complex, naturalistic system – cannot teach us about fundamental aspects of cognition. Indeed, recent research in the field of music psychology has contributed to our basic understanding of how we perceive and understand the world, informing broad topics such as skill acquisition, learning, memory, emotion, and experience-dependent plasticity (to name a few). Throughout this course, we will examine how the scientific study of the musical mind is important for understanding fundamental psychological processes.

#### 3.0 COURSE LEARNING OBJECTIVES

By the end of the course students should:

- Develop an appreciation of both empirical and theoretical work in music cognition
- Situate any weekly topic in a larger psychological context, as well as understand the extent to which music offers a unique window into understanding a specific psychological construct
- Refine critical thinking skills and evaluation of psychological experiments, arguments, and practices
- Refine knowledge mobilization and science communication skills

## 4.0 DESCRIPTION OF CLASS METHODS

The course meets in-person every Tuesday and Thursday (9:30-11:30am, HC-V107). Each class will be devoted to discussing 1-2 assigned readings. Active participation is a critical component of this course, so please be sure to come to class prepared (i.e., having read the article(s) and coming up with at least two questions for the discussion).

Content is structured around **four themes**, with each theme covering three weeks of the semester. The first two themes (Foundations, Perception and Cognition) provide a background in auditory science and core musical constructs, whereas the final two themes (Musical Development, Musical Meaning) apply this foundation to different topics. For the first two themes, short explanatory videos will be uploaded to OWL to help orient you to some of the terminology (e.g., What do we mean by pitch? What do we mean by rhythm?) These videos can be viewed asynchronously.

Over the course of the semester, each student will be responsible for leading the discussion one week and serving as the "principal discussant" a different week. When it is your week to lead discussion, your responsibilities include (1) preparing a discussion outline, and (2) developing extra discussion questions and possible activities (e.g., in-class demonstrations). When it is your week to serve as the "principal discussant," you will read the assigned materials extra closely, contribute to the discussion significantly, and "jump in" with thoughts when there are lulls in the discussion. Discussion leader and principal discussant roles will be assigned the first day of class.

### 5.0 TEXTBOOKS AND OTHER REQUIRED RESOURCES

There are no required textbooks for this course. The readings for the course primarily take the form of peer-reviewed journal articles and each reading will be posted to OWL.

### 6.0 METHOD OF EVALUATION/ASSESSMENT

## Statement Regarding Grades in Psychology Courses at Huron University College

## Statement Regarding Academic Accommodation in Psychology at Huron University College

In the Department of Psychology at Huron, courses are structured to allow students as much flexibility as possible. In the event of an acute medical illness or other personal emergency, students must request academic consideration as per Western Academic Senate Policy. The instructor must indicate on the course outline how accommodations are granted and arranged.

Student requests for academic consideration/accommodation for missed work must be submitted in a timely manner, typically no more than 48 hours after the missed evaluation. Requests submitted more than 48 hours after the missed evaluation will normally require a formal recommendation from an Academic Advisor.

For missed coursework worth less than 10% of the overall grade in a course, students should contact the instructor in writing as soon as possible to arrange for accommodation. In cases where accommodation is granted, the instructor will inform the student in writing what accommodation will be granted (e.g. makeup test, reweighting missed evaluation, accept late assignment).

For missed coursework worth 10% or more of the overall grade in a course, students must contact their home faculty Academic Advising office with appropriate documentation (at Huron, this is Huron's Academic Advising Office; if you are a student at a different campus, contact your academic advisor at your home campus).

In the Department of Psychology, if accommodation is granted, students will typically be granted an extension of 48 hours for written essays and reports from the time when accommodation is granted in writing, unless otherwise discussed with the course instructor. The typical accommodation for missed tests will be reweighting of the course grade, unless otherwise discussed with the course instructor. Instructors may request further documentation to approve accommodations.

Such activity is disruptive and distracting to other students and to the instructor, and can inhibit learning. Students are expected to respect the classroom environment and to refrain from inappropriate use of technology and other electronic devices in class.

## Statement on Use of Personal Response Systems ("Clickers")

Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence.

### Academic Consideration for Missed Work

All students pursuing academic consideration, regardless of type, must contact their instructors no less than 24 hours following the end of the period of absence to clarify how they will be expected to fulfill the academic responsibilities missed during their absence. Students are reminded that they should consider carefully the implications of postponing tests or midterm exams or delaying submission of work, and are encouraged to make appropriate decisions based on their specific circumstances.

### Policy on Academic Consideration for a Medical/Non-Medical Absence

(a) Consideration on <u>Medical Grounds</u> for assignments worth *less than 10%* of final grade: Consult Instructor Directly and Contact Academic Advising

When seeking consideration on **medical grounds** for assignments worth *less than 10%* of the final course grade, the student should contact the instructor directly. The student need only share broad outlines of the medical situation. The instructor **may** require the student to submit documentation to the academic advisors, in which case she or he will advise the student and inform the academic advisors to expect documentation. If documentation is requested, the student will need to complete and submit the <u>Student Medical Certificate</u>. The instructor may <u>not</u> collect medical documentation. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation.

# b) Medical Grounds for assignments worth 10% or more of final grade: Go Directly to Academic Advising

University Senate policy, which can be found at <u>Academic Calendar - Western University (uwo.ca)</u> requires that all student requests for accommodation on medical grounds for assignments worth 10% or more of the final grade be made directly to the academic advising office of the home faculty (for Huron students, the "home faculty" is Huron), with supporting documentation in the form (minimally) of the Senate-approved Student Medical Certificate found at:

The documentation is submitted in confidence and will not be shown to instructors. The advisors will contact the instructor when the medical documentation is received, and will outline the severity and duration of the medical challenge as expressed on the Student Medical Certificate and in any other supporting documentation. The student will be informed that the instructor has been notified of the presence of medical documentation, and will be instructed to work as quickly as possible with the instructor on an agreement for accommodation. The instructor will not normally deny accommodation where appropriate medical documentation is in place and where the duration it describes aligns with the due date(s) of assignment(s). Before denying a request for accommodation on medical grounds, the instructor will consult with the Dean. The instructor's decision is appealable to the Dean.

# c) Consideration on Non-Medical Grounds: Consult Huron Support Services/Academic Advising, or email <a href="https://doi.org/10.2016/nc.2016/n

Students seeking academic consideration for a **non-medical** absence (e.g. varsity sports, religious, compassionate, or bereavement) will be required to provide appropriate documentation. All consideration requests must include a completed <u>Consideration Request Form</u>. Late penalties may apply at the discretion of the instructor.
